CNN: GOP governors 'giddy' in wake of Trump's win

Republican governors said they were "giddy" Tuesday over the prospect of more control of federal education, health care and transportation dollars under a Donald Trump administration. At the first major gathering of Republicans since Trump's victory, high-profile governors largely set aside the topic of the President-elect himself. Instead, they said they're thrilled that the GOP controls both Congress and the White House. And they're excited about the promotion within their own ranks, with Indiana Gov. Mike Pence set to become vice president. "I'm just giddy, and if you talk to any of the governors here, we are so excited at the possibility and the opportunities that are going to be here," said South Carolina Gov. Nikki Haley. "The idea that now we can start to really govern -- I have never known what it's like to have a Republican president. I can tell you that the last five years, Washington has been the hardest part of my job," Haley said. "This is a new day."

Gov. Rick Scott called for "disruptive change" in a Donald Trump administration - while admitting that on many issues, he doesn't know what trump will do. He also appeared to open the door to a potential U.S. Senate run in 2018 for incumbent Bill Nelson's seat - but he punted when directly asked about Trump's widely condemned appointment of Breitbart editor Steve Bannon as chief adviser. Scott was speaking to reporters at the at the Waldorf Astoria Orlando Tuesday on the first full day of Republican Governors Association conference, which brought together governors from across the country just a few weeks after they won control of what will be 34 governorships across the nation. Scott repeatedly

compared Trump's rise as an "outsider" businessman to his own election as governor in 2010.

NOTE: At a joint press conference later in the day, Scott, New Mexico Gov. Susana Martinez, Wisconsin Gov. Scott Walker, South Carolina Gov. Nikki Haley all avoided comment on Bannon, with Haley also saying she did not know him.

NOTE: But Haley, who opposed Trump earlier this year, advised the president-elect that "communication and tone matter. The power of words matter. ... What you never want to see is any divisiveness in a state or the country."

It's Donald Trump's Republican Party now, but several of the Republican governors he repeatedly made uneasy over the past year will gather in Florida today to lay out their visions for governing. The Republican Governors Association holds its annual conference today and Wednesday at the Hilton Orlando Bonnet Creek where governors including Florida's Rick Scott, will preside over the first major gathering of GOP leaders since the election. Scott is the most enthusiastic supporter of the president-elect among the governors scheduled to attend.

NOTE: Other governors expected include South Carolina's **Nikki Haley** (who denounced Trump early in the year but eventually said she would vote for him); Utah's Gary Herbert (who said he would not vote for him after the Access Hollywood tape came out); Incoming RGA Chairman Scott Walker of Wisconsin (who backed Ted Cruz over Trump at the end of the presidential primary); Arkansas' Asa Hutchinson (who eventually backed Trump and is said to be contender for Trump's attorney general); Arizona's Doug Ducey; New Mexico's Susannah Martinez (who openly sparred with Trump); Georgia's Nathan Deal; Greg Abbott of Texas; and Tennessee's Bill Haslam (who at one point called on Trump to step aside and let Mike Pence be the nominee).

S.C. Gov. Nikki Haley and schools chief Molly Spearman are encouraging lawmakers to make the state's top education post an appointed position. In a letter to legislators, Haley and Spearman urged the General Assembly to pass a resolution allowing the governor to appoint the superintendent of education. Voters would make the final decision through a referendum. South Carolina is one of 13 states where the education superintendent is elected. "Instead of moving the state forward with a common vision for education priorities, this divided leadership structure can result in ... a lack of

coordination and fragmented accountability for failures in our pre-K-12 education system,” the two Republicans wrote. State Sen. Chip Campsen, R-Charleston and state Rep. Greg Delleney, R-Chester, will pre-file a bill to make the post a cabinet position next month.

South Carolina's 2018 governor's race saw its first casualty Monday but otherwise the field of those interested remained intact after last week's news that popular Republican U.S. Sen. Tim Scott and congressman Trey Gowdy are considering running as a ticket. Former federal judge Billy Wilkins, one of at least eight Republicans mulling bids, confirmed he will not be a candidate when the real politicking begins next year. "I plan to continue to be active in the political life of South Carolina, but not as a candidate for public office," Wilkins, a retired federal judge from Greenville, told The Post and Courier. Wilkins is the former 4th Circuit U.S. Court of Appeals chief judge. He said Monday he was unaware of the possible Scott-Gowdy hook-up. Otherwise there were no losses in the field of probables Monday.

NOTE: Scott vies with Gov. Nikki Haley as the state's most popular Republican. He is the first black Republican elected to represent South Carolina in the Senate since Reconstruction. Gowdy built name recognition after leading the Benghazi investigation panel, Winthrop University political scientist Scott Huffmon said.

NOTE: The pair's decision on a run is expected by year's end. South Carolina voters will elect a governor and lieutenant governor on the same ticket for the first time in 2018. Haley is not eligible for a third consecutive term.

The State: Rec Commission board member resigns

One of the seven Richland County Recreation Commission board members that Gov. Nikki Haley intends to fire has walked away on his own. Wilbert Lewis resigned Tuesday, becoming the only board member to step down after turmoil at the troubled commission. Lewis was not one of the five board members that a group of Richland County legislators had accused of allowing unwarranted pay raises and widespread nepotism at the commission. After those lawmakers requested Haley remove the five board members, the Republican governor moved to fire all seven. "Although I believe he is one of the few on this board who have acted in the best interest of the agency and the employees, I respect his decision to allow the commission to move forward with a new board in a new direction," said state Sen. Joel Lourie, D-Richland. "His departure should be viewed as a sacrifice by a respected public servant who is putting the greater good ahead of his personal ambition."

Circuit Judge Diane Schafer Goodstein of Summerville is one of three finalists who made the early cut to run for a seat on the S.C. Supreme Court. Now she and two others will begin lobbying state lawmakers to elect them. Goodstein joins judges Ralph King "Tripp" Anderson III of Columbia and George C. James of Sumter in their quest to fill the seat opening when S.C. Supreme Court Chief Justice Costa Pleicones retires at the end of the year. Goodstein serves as a judge in the 1st Judicial Circuit. After easily selecting Anderson, an Administrative Law Court judge, and James, who serves in the 3rd Judicial Circuit, the legislative review panel members deadlocked on the third choice. After a 45-minute break, the Judicial Merit Selection Commission agreed to move Goodstein forward. None of the judges were present during the vote.

Associated Press: State agency suspends changes to abortion regulations

A South Carolina agency is holding off on recommending any changes to abortion clinic regulations after being inundated with responses to its drafted proposal. The state Department of Health and

Environmental Control confirmed Tuesday the process is delayed indefinitely. Spokeswoman Cassandra Harris says the agency received nearly 460 comments on proposed changes put out in September for public review. The agency had expected to hold a hearing in December, then send recommendations to legislators. Abortion rights advocates praised the department's move. Suggestions they opposed included requiring physicians who perform abortions to be board-certified in obstetrics and gynecology and requiring clinics to meet higher surgical standards. Planned Parenthood regional spokeswoman Vicki Ringer says the decision shows South Carolinians "spoke out loudly and in huge numbers" to oppose medically unnecessary restrictions.

WCIV: Cell phones in prisons putting public safety at risk, officials say

Prison officials say contraband is a common problem at all prisons in South Carolina. At Lieber Correctional Institution in Dorchester County, 169 cell phones were found during a 12-month period. So, what's being done to stop cell phones and other contraband from coming into prison dormitories? Miles of razor wire fence outside Kirkland Correctional Institution in Columbia isn't enough to prevent crimes from sneaking inside. Nearly every day a special group of corrections officer goes beyond the brick and mortar walls of the maximum security prison to find forbidden items. The video above provides a rare look at a contraband team tackling the task of detecting dangerous weapons like shanks. "Conduct a complete search, counterclockwise, clockwise," said Col. Gregory Wells. "Top and bottom of the floor. Checking every item in the cell." Uncovering contraband doesn't take officers long. Within moments they quickly come across banned products hidden in soap containers, cracks of walls and underneath toilet bowls.

NOTE: Bryan Stirling, the director of the South Carolina Department of Corrections said there are countless items confiscated from South Carolina's 25 prisons. Among those items taken from prisoners -- hundreds and hundreds of cell phones. He said cell phones are the top choice when it comes to the contraband prisoners want to get their hands on.

NOTE: "It allows them to reach out to victims. Things of that nature," Stirling said. "They can also continue their criminal ways because they can use their cell phones to exchange money and to come up with schemes to continue making money while they are incarcerated."

NOTE: Governor Nikki Haley and other governors are asking the FCC to reconsider blocking cell phone signals inside prisons.

S.C. Attorney General Alan Wilson joined two of his counterparts in urging President-elect Donald Trump and his transition team not to transfer terror detainees from Guantanamo Bay to the United States. In a letter Tuesday, Wilson and fellow Republican Attorneys General Cynthia Coffman, of Colorado, and Derek Schmidt, of Kansas, asked Trump to intervene on any relocation plan of Gitmo prisoners to sites in their states as a matter of "unparalleled concern." "We would be derelict to accept conclusory press reports and assume he will leave office with Guantanamo operational," the letter said, referencing President Barack Obama. "There remains a very real possibility the president may choose to push beyond his executive authority and move these terrorists to our country."

Familiar lament: There's too much money in politics. Contrarian theory: There's not enough money in

politics. Well, at least there's not enough money in the salaries we pay to the folks who win our political races. For instance, why did so many Americans find both 2016 major party presidential nominees so sadly lacking? Maybe it's because, in part, that the highly stressful job pays a lowly \$400,000 a year. Michigan football coach Jim Harbaugh, at \$9 million a year and roughly a million more if he wins enough games and awards, makes nearly \$400,000 every two weeks. That makes him the highest-paid public employee in the United States. Indeed, the list of the highest-paid public employees in our nation is dominated by mostly college football and a few college basketball coaches. Clemson football coach Dabo Swinney, at \$4.42 million a year, is the highest-paid public employee in our state and 12th highest-paid college football coach in our nation

NOTE: And why should Swinney, especially after blowing that game, make 41.7 times more than Gov. Nikki Haley's \$106,078 a year? Haley, a Clemson grad who at times wears the orange, hasn't complained about that pay — and gender? — gap. As a right-thinking free-market fan, she doubtless respects the supply-and-demand forces that make being a college football coach who wins enough to keep his job a lucrative gig.

Speaker Paul Ryan unanimously won his GOP colleagues' votes on Tuesday for another term at the helm of the House. He told fellow Republicans he had President-elect Donald Trump's support, and heralded "the dawn of a new, unified Republican government." "It feels really good to say that actually," Ryan told reporters. "This will be a government focused on turning President-elect Trump's victory into real progress for the American people." While victory was the GOP unifier, Democrats were verging on disarray. House Democrats abruptly announced Tuesday that they were delaying their own leadership elections set for Thursday until Nov. 30 to give lawmakers more time to process

disastrous election results. It's not clear whether the election delay might morph into a real challenge to Minority Leader Nancy Pelosi, D-Calif. She has led House Democrats for more than 12 years and has consolidated support with strong fundraising and an ability to deliver votes, but there's long been grumbling from Democrats who say new leadership is needed at the top.

Hidden from the public in his Manhattan high-rise, Donald Trump huddled Tuesday with Vice President-elect Mike Pence as he tried to fill out key posts in his Cabinet. But the transition team appeared to be straining under the enormous challenge of setting up an administration. Former Rep. Mike Rogers, a respected Republican voice on national security issues, announced he was stepping down from the transition effort. And an apparent clerical oversight effectively halted the Trump team's ability to coordinate with President Barack Obama's White House. With Trump out of sight now for several days, his allies engaged in an unusual round of public speculation about his potential appointments — including their own futures — as the president-elect and his aides weighed the nation's top national security posts.

Never mind closing Guantanamo. It might be getting bigger. President Barack Obama is running out of time to fulfill his longstanding promise to shutter the prison at the U.S. military base in Guantanamo Bay, Cuba. Sixty inmates remain in the facility and only a third are cleared for release. If Obama can't close it, his successor likely won't. Donald Trump has not only pledged to keep Guantanamo open, in April he said that "we're gonna load it up with some bad dudes, believe me. We're gonna load it up." He told The Miami Herald in an interview that month that he would support trying U.S. citizens accused of terrorism at the base, though that would require Congress to change federal law and would likely face constitutional challenges. Opened in 2002 as a makeshift camp to hold men captured in the early fight against al-Qaida, Guantanamo has become a symbol of the strong-handed U.S. response to the Sept. 11, 2001, attacks. Its advocates say it keeps dangerous terrorists locked up. Opponents say it violates basic human rights, with prisoners held indefinitely without charges. Obama has said it feeds anti-U.S. sentiment worldwide and that the prisoners could be held for less money at facilities in the United States.

Democratic mayors of major U.S. cities that have long had cool relationships with federal immigration officials say they will do all they can to protect residents from deportation, despite President-elect Donald Trump's vows to withhold potentially millions of dollars in taxpayer money if they do not cooperate. New York City's Bill de Blasio, Chicago's Rahm Emanuel and Seattle's Ed Murray are among those in "sanctuary cities" that have tried to soothe worried immigrant populations. "Seattle has always been a welcoming city," Murray said Monday. "The last thing I want is for us to start turning on our neighbors." In Providence, Rhode Island, Mayor Jorge Elorza, the son of Guatemalan immigrants, said he would continue a longstanding policy of refusing to hold people charged with civil infractions for federal immigration officials. Newark, New Jersey's Ras Baraka echoed that decision, calling Trump's rhetoric on immigration "scary."

Greenville Water officials are monitoring their water to make sure the Pinnacle Mountain Fire doesn't force them to change their supply. The fire is being directed toward the Table Rock Reservoir, one of three sources for the water company. One of the risks is that an exceptionally heavy rain could send piles of soot into the water, which would require either extra treatment methods or a switch to lean even more on the other two sources, the North Saluda Reservoir and Lake Keowee, said Olivia Vassey, communications manager for the water company. The soot risk will diminish over time and smaller amounts of rain would not pose as much of a risk to the water supply, she said. As smaller rains fall and leaves start to layer over the fire debris and nature takes over, any risk of soot in the water system will likely go away, Vassey said.

Children with asthma and other respiratory illnesses are particularly hard hit by the clouds of smoke from area wildfires hovering over the Upstate, a local pediatrician says. So special precautions should be taken at home, in schools and in the community to protect them, said Dr. Steven Snodgrass, medical director of pediatric pulmonology for Greenville Health System Children's Hospital. Outdoor exposure should be limited in these vulnerable children, especially if they are already battling colds and respiratory illnesses at this time of year, he said. And windows should be closed to limit exposure. Requests from parents and caregivers to skip recess and other outdoor activities should be honored, he said, along with athletes participating in outdoor sports who are susceptible.

"Smoke from these fires can irritate the eyes and respiratory system, as well as aggravate or exacerbate chronic heart and lung diseases," said Rhonda Thompson, chief of DHEC's Bureau of Air Quality. People with respiratory health issues are advised to limit their time outdoors to avoid the smoke and to take measures to prevent outdoor smoke from getting inside, according to DHEC. Keep windows and doors closed and keep fresh-air intakes closed and filters clean in air conditioning and central heating units to prevent smoke from getting inside, officials said.

Over the weekend, more evacuations were enacted for the area, including in Henderson County communities near the fire along Highway 9 and Shumont Road. So far, the North Carolina Forest Service reports, the fire has prompted the evacuations of about 1,000 people. The fire is still 15 percent contained. Chief Rick Livingston, of Mills River Volunteer Fire Department, said firefighters from Mills River have been working the fire through the weekend and will continue to keep working it for the rest of the week, prepping structures by blowing away leaves and debris to clear out the areas in advance of the fire. As the fire gets closer to the Bat Cave area, Livingston's crew of paid and volunteer firefighters will likely do more front-line work, he said, and are already running at 100 percent.

The Double R Farm has produced abundant crops for four generations of Rabon family farmers here, and despite the double whammy of record rains during the October harvest last year and last month's hurricane, they are determined to weather the hardship. "I'll do whatever I gotta do, even if it means I'm worn out and broke," says Ronald Rabon. "But if I make it this year, it will take a miracle from the Lord." Tropical storm-force winds and 12 inches of rain from Hurricane Matthew battered 700 acres of his cotton just as the bolls began to open, resulting in hardlock that made picking nearly impossible. They were able to salvage about 100 acres, mostly from farm lands tucked among wooded areas protected from the wind. After Hurricane Matthew passed, evacuees stuck close to your phones and TV's waiting for the call to come back home.

And it was that Sunday night after the storm that the South Carolina Emergency Management Division announced the evacuation order for Beaufort and Jasper Counties had been lifted. Hundreds of families the road, only to find they weren't allowed back after all. There are two sides to the story of why that happened and they come from the sheriff of Beaufort County and the Governor of South Carolina. Press conference after press conference, email after email, Facebook posts and tweets, all made by the ones managing the evacuation and reentry to Beaufort County after the storm. You can't say they kept quiet, but the messages delivered didn't match up. "We had some communication glitches no doubt," State Representative Weston Newton said. The smooth operation of getting tens of thousands of people out of Beaufort County before Matthew's landfall was soon overshadowed by the tension of getting back home.

NOTE: "I went upstairs and followed through with what we talked about at the press conference," Tanner said. "And it was made clear during that time that Hilton Head was not open, it was closed and at that particular time we made it clear that the sea islands of Beaufort County were not open for return."

NOTE: But SC Governor Nikki Haley told NEWS 3 during a recent visit to Jasper County that a different message came through from Beaufort County officials. "We made sure from the EMD director to the sheriff, who was over the EMD director, as well as I think the mayor and county council, we make sure we get the all clear before we lift any sort of restriction," Haley said.

NOTE: The governor said based on what she heard local officials say, Beaufort County was safe for return. "We rely on the county and to tell us when we lift the evacuation," Haley said in a press conference.

Spartanburg County Sheriff Chuck Wright said he plans to speak with lawmakers about expediting cellphone records requests after a missing persons case out of Anderson led to the discovery of a suspected serial killer hiding in plain sight. "It's just not a fast process. I want to see if we can request something sooner, but there has to be oversight," Wright said. "We can't just say, 'Hey, I need this today.' They're private businesses. They're not government-owned." Wright has spoken with U.S. Rep. Trey Gowdy, R-S.C., about a potential change in the law governing records requests. It's an issue that's been before Congress in the past, and likely will continue to be discussed as digital records become even more important in investigations. "Law enforcement has a very difficult job, where seconds can mean life or death," Gowdy said in a statement. "The cellphone providers certainly can make the information available in as timely a fashion as they want. To the extent these providers need additional incentive, I anticipate Congress continuing to look at this and related issues."

The judge in the murder trial of a former South Carolina patrolman charged in the shooting death of a

black motorist has ruled that the prosecution may present its final witness. The prosecution wants crime scene investigator Bill Williams of Georgetown to take the stand. He has created an animation of the shooting of Walter Scott by Michael Slager using cellphone video, dashcam video and police radio calls. Slager, who is white, is charged in the April 2015 shooting death of Scott as he fled a traffic stop. Williams is largely self-taught and the defense argued he lacked the formal training to be allowed to testify as an expert. The jury was out of the courtroom for more than four hours Tuesday as attorneys argued and Williams showed the judge his presentation. Finally, Circuit Judge Clifton Newman ruled the witness has expertise in both crime scene recreation and forensic video. Court has adjourned and the jury will see the animation on Wednesday.

Prosecution witness Anthony Imel, a forensic video analyst who works at the FBI lab in Quantico, Virginia, testified Monday and the jury was shown enhanced footage he made from the video taken the day the 50-year-old motorist was shot.

A federal judge has delayed a hearing to determine whether Dylann Roof is competent to stand trial in the deaths of nine people at a Charleston church. U.S. Judge Richard Gergel issued a ruling Monday saying the psychologist examining Roof won't finish a report until Tuesday. So Gergel delayed the competency hearing by a day to Thursday. It is still unclear whether the hearing will be open to the public. Roof's lawyers say it must be closed to protect his right to a fair trial. Prosecutors in the death penalty case and several news organizations want the hearing to remain open. Roof's lawyers also filed a request Monday to be allowed to file briefs after the hearing, which if granted could further delay jury selection, set to start next Monday.

Roof, 22, of Columbia, an avowed white supremacist, is accused in a federal indictment of killing nine African-Americans in a mass shooting in June 2015 at a historic downtown Charleston church. Prosecutors are seeking the death penalty. Thursday's hearing will determine whether U.S. Judge Richard Gergel orders Roof's trial, now scheduled to begin Nov. 21 with jury selection, will go on as scheduled or postponed indefinitely.

Associated Press: NTSB: 2 midair collisions show limits of 'see-avoid' plans

The National Transportation Safety Board reported Tuesday that two mid-air collisions in 2015 show the limits of "see and avoid" strategies and suggests air traffic controllers and pilots buy better cockpit technology to help avoid such deadly crashes. NTSB officials read reports in Washington on the two accidents that claimed the lives of seven people, saying existing safety mechanisms failed. The "see and avoid" strategy requires a pilot to see another aircraft and take evasive action in time to avoid a collision. "We want to highlight the limitations of the see-and-avoid concept and call attention to the alternatives," NTSB spokesman Peter Knudsen said following the presentation. "There are affordable options for pilots to install equipment that can help avoid such incidents." The first collision happened over Moncks Corner, South Carolina, between a Cessna and an Air Force F-16 fighter. Two people in the small plane were killed but the jet pilot ejected safely.

An air traffic controller who told an Air Force fighter jet pilot to turn left instead of right has been found to have contributed to a collision with a civilian Cessna over the Cooper River that left two Moncks Corner men dead. The jet pilot, who used an autopilot to turn his F-16 instead of grabbing the stick, wasn't found to have contributed to the crash. But National Transportation Safety Board inspector Dennis Diaz said the controller did not violate the rules and that the right turn assessment was made "in hindsight." The board report issued Tuesday delineates probable cause and can make recommendations to avoid future crashes. The aircraft collided July 7, 2015, near Lewisfield Plantation. Father and son Mike and Joe Johnson died aboard the Cessna. Their bodies were recovered in the river. Joe Johnson, 30, the pilot, had taken off from Moncks Corner airport minutes earlier and was flying to Myrtle Beach for the day.

Hollingsworth is the teacher who helped escort students to safety during a shooting at Townville Elementary School on Sept. 28. School officials did not provide the name of Hollingsworth's father, citing requests for privacy by the family. Fluor Daniel, a Texas-based construction and engineering company with significant operations in the Upstate, said in a prepared statement that it does not identify employees by name and would not confirm what type of work the employees were doing in Afghanistan.

The church, owner of the bus carrying the Ramah JUCO football team from Rock Hill, wants a lawsuit filed last month in Chester thrown out. The suit was filed by 21 players and coaches that alleged the church failed to properly maintain,

service and inspect the bus and its tires. A blown tire led to the bus hitting a guardrail and a bridge, police said. The crash killed four people, including the driver, who was a church member, and injured 39 others. Federal officials have said the bus was not licensed for for-hire service, yet the team chartered the bus.

A group known as the Association of Artists for Change has claimed responsibility for the display, which Winthrop University police were initially investigating as an act of vandalism.

The State: Stinking air chokes neighborhood

The stench that hangs over Quail Lane is so powerful at times that people stay indoors, hoping to escape the nauseating odor that causes some of them to feel queasy. Cookouts, jogs through the neighborhood, tennis games at a community racquet club — even raking leaves — are less appealing with the smell of raw sewage in the air, say residents of the area near Trenholm Road. Last month, the odor soured a Halloween party at the club, according to emails from residents to a local lawyer. Children ask ““What is that smell? That is gross,”” neighborhood resident Ramsay Bokinsky said in an interview Monday with The State newspaper. “I don’t think it is acceptable that there is a constant sewage smell in the middle of a residential community.” The source of the odor appears to be the East Richland County Public Service District. After the utility finished an \$8 million improvement project at a sewage pump station last spring, neighbors said they began to notice the consistent and pervasive stink. Not only does it curtail outdoor activities, but some residents say they won’t open windows or French doors.

The U.S. Drug Enforcement Administration put the synthetic opioid U-47700 on its most restrictive list of controlled substances Monday, calling it an imminent threat to public health. The action comes as Anderson County is poised to enact its own ban on these types of drugs. The drug, which has some morphine-like qualities, has been linked to at least 46 deaths in the United States in a period of about a year, including 10 deaths in neighboring North Carolina. Federal DEA officials believe the nationwide death toll may be much higher, but say the presence of U-47700 may be overlooked if a person is also testing positive for more commonly known drugs, such as heroin or the painkiller oxycodone.

Greenville Health System on Tuesday announced plans for a new psychiatric hospital on Grove Road that it will build in partnership with Acadia Healthcare. The \$64 million, 80,000-square-foot facility is slated to open in March 2018 and will provide expanded services as well as additional beds for a region hampered by a dearth of mental health care. The 120-bed hospital will provide 52 more beds than are currently available at the aging Marshall I. Pickens Hospital, said Dr. Kenneth Rogers, chairman of psychiatry at GHS. It will be built on the site of the old Blood Connection building, he said, and once completed, the old Marshall Pickens hospital will be razed to make way for other hospital needs. In addition to much-needed psychiatric hospital beds, the facility will also provide other services, such as substance abuse and geriatric mental health programs, he said.

Island Packet: Supermoon brings super high tides, coastal flooding to the Lowcountry

The epic supermoon that lit up the sky Monday night is triggering elevated tides and flooding in the coastal areas along the East Coast, including Beaufort County. High tide on Broad Creek peaked Tuesday morning at 10 feet, roughly 2 feet above normal, according to Saltwatertides.com. Highest tide will stay elevated above 9 feet through Wednesday in the Broad Creek and Calibogue Sound areas. The National Weather Service issued a coastal flood advisory for the area Tuesday. On the

Associated Press: 5 Utah students stabbed at high school, teen in custody

Five students were stabbed inside the boys' locker room of their Utah high school Tuesday and a 16-year-old student was taken into custody after school workers risked their lives to box him into a corner, police said. The suspect, a straight A student with no record of disciplinary problems, stabbed himself in the neck at Mountain View High School before he was subdued with a Taser by an officer working at the school, said Gary Giles, the police chief in the small city of Orem about 40 miles south of Salt Lake City where the attack happened. The suspect used a knife with a 3-inch blade to attack the five male victims, Giles said. The school staffers managed to contain him for several minutes and prevent any more possible bloodshed until police arrived, he said. He said police were investigating why the student attacked his classmates at about 8 a.m. as they were getting ready for the morning physical education class at the start of the school day.

Associated Press: Obama: World leaders must heed people's economic fears

Drawing a broad lesson from the election of Donald Trump, President Barack Obama said Tuesday that world leaders need to pay attention to people's very real fears of economic dislocation and inequality in the midst of globalization. "The more aggressively and effectively we deal with those issues, the less those fears may channel themselves into counterproductive approaches that can pit people against each other," Obama said as he opened the last foreign tour of his presidency. Obama, in a joint news conference with Greek Prime Minister Alexis Tsipras, said that both Trump's election and the British vote to leave the European Union reflected the need to deal with "people's fears that their children won't do as well as they have." "Sometimes people just feel as if we want to try something and see if we can shake things up," Obama said.
