The 2nd Annual Basque Fry will be held Saturday, August 20, 2016 at Corley Ranch in Gardnerville, Nevada from 10am until 2pm. Gardnerville is 60 minutes south of Reno by car; there are two private airports near the ranch.

This year our currently confirmed speakers are Ambassador John Bolton, Senator Tom Cotton, Nevada Congressman Dr. Joe Heck and Sheriff David A. Clarke, Jr. of Milwaukee, Wisconsin.

The Basque Fry event is hosted by the *Morning in Nevada PAC*. In 2015, in addition to numerous Nevada Republican activists, voters and elected officials, we had in attendance a number of national leaders in our party. The Basque heritage is rich in Nevada.
