I have reached out to every church, non-profit organization, and available resources all to hear them say they are out of funding. I am contacting you because I am in a state of emergency. I will be a tax paying hard working "homeless" mother if I don't get this eviction straightened out. That doesn't even sound right. I'm reaching out to you, and I hope that as you being a mother you can understand my fears right now. I am employed by GICS Foods I work Mon-Thurs. 7-5. June 25 makes a year I have been there. My previous employer relocated to Mexico last year leaving a strain on bills as well, but the good Lord made a way. I have until tomorrow to come up with \$50.00. I get paid on Monday I will have 400 of it.

I sincerely hope that this letter
doesn't fall on deaf ears.

I have been a taxpayer here in SC
for ever since I can remember (16 in total)
So now I'm asking my State to help me
as a mother in my state of emergency.
