Statewide Summary – Most roads are dry (normal) condition, however some – (mostly secondary roads) are still covered with snow/ice with well below freezing temperatures into the morning for the entire state. Therefore, icy conditions on roadways will continue to be a spotty problem. Travel on secondary roads will likely be treacherous in sections and is not recommended unless absolutely necessary. 5 of the 7 Engineering District continue working on rotating 12-hour shifts applying salt and other anti-icing/deicing materials. Statewide, all interstate routes are open and in fair condition. The Ravenel Bridge in Charleston is still closed. The following values are the employees and equipment that are active, and the material already applied to the roadways.

Engineering District 1 (Kershaw, Lee, Lexington, Richland and Sumter Counties) –Temperatures in District One are ranging between 13 and 18 degrees. All routes (interstate, primary and secondary) are generally clear of snow and ice. However, many pavements that were in wet condition during the day are being monitored and spreader crews will be available tonight to apply salt/sand/de-icing chemicals as necessary. Operations have been completed in Lee County. Work is almost complete in all counties.

Engineering District 2 (Abbeville, Anderson, Edgefield, Greenwood, Laurens, McCormick, Newberry and Saluda Counties) –Temperatures in District Two are ranging between 12 and 15 degrees. The weather is clear to cloudy throughout the district. Secondary roads and bridges continue to be treated in spots with anti-icing and deicing materials. All interstates are in good condition. Work is almost complete.

Engineering District 3 (Greenville, Oconee, Pickens and Spartanburg Counties) –Temperatures in District Three are ranging between 5 and 15 degrees. District 3 Operations have been completed.

Engineering District 4 (Cherokee, Chester, Chesterfield, Fairfield, Lancaster, Union, and York Counties) – Temperatures in District Four are ranging between 12 and 16 degrees. The interstates are in fair or good condition and snow removal and anti-icing treatment on both primary and secondary routes is the focus now along with responding to requests from 911 and Highway Patrol. Primary and secondary roads are partially covered with snow and ice in spots.

Engineering District 5 (Darlington, Dillon, Florence, Georgetown, Horry, Marion, Marlboro, and Williamsburg Counties) – Temperatures in District Five are ranging between 18 and 28 degrees. Priority routes and bridges continue to be treated with anti-icing and deicing materials and equipment. Secondary roads are partially covered with snow and ice where most of the work is focused now.

Engineering District 6 (Beaufort, Berkeley, Charleston, Colleton, Dorchester, and Jasper Counties) – Temperatures in District Six are ranging between 23 and 28 degrees. The primary concern continues to be the opening the Ravenel Bridge in the Charleston and returning it to good condition. Additional resources are currently assisting Charleston with their efforts. SC 170 (Alligator Alley) in Jasper County remains closed and rerouted due to ice on bridges in Georgia. Route conditions vary from dry in Berkeley and Colleton to partially covered with ice in Charleston. County crews are monitoring and treating routes, as necessary, with anti-icing and deicing materials and equipment.

Engineering District 7 (Aiken, Allendale, Bamberg, Barnwell, Calhoun, Clarendon, Hampton, and Orangeburg Counties) – Temperatures in District 7 range from 14 to 19 degrees. District 7 Operations has returned to skeleton crews in the field offices. Most routes are dry. District 3 Operations have been completed.

Statewide Summary – Most roads have returned to dry (normal) condition, however some – (mostly secondary roads) are still covered with snow/ice. Temperatures are below freezing this morning statewide. Temperatures are forecast to be above the freezing mark for most of the state this afternoon; this will help accelerate ice removal efforts. While this is encouraging news, icing will continue to be a lingering problem on our roadways until this afternoon. Travel on secondary roads may be treacherous in sections and extreme caution is recommended. Crews in 4 of the 7 Engineering District continue working on rotating 12-hour shifts applying salt and other anti-icing/deicing materials. We anticipate most Engineering Districts will return to normal operations by this afternoon. Statewide, all interstate routes are open and in fair or better condition. The Ravenel Bridge in Charleston is still closed. The following values are the employees and equipment that are active, and the material already applied to the roadways.

Engineering District 1 (Kershaw, Lee, Lexington, Richland and Sumter Counties) –Temperatures in District One are ranging between 12 and 20 degrees. All routes (interstate, primary and secondary) are generally clear of snow and ice. However, many pavements that were in wet condition during the day are being monitored and spreader crews are available to apply salt/sand/de-icing chemicals as necessary. Operations have been completed in Lee and Sumter Counties. Work is almost complete in all counties.

Engineering District 2 (Abbeville, Anderson, Edgefield, Greenwood, Laurens, McCormick, Newberry and Saluda Counties) –Temperatures in District Two are ranging between 12 and 15 degrees. Secondary roads and bridges continue to be treated in spots with deicing materials. All interstates are in good condition. They plan to clean up and repair equipment later today and return to normal operations.

Engineering District 3 (Greenville, Oconee, Pickens and Spartanburg Counties) –Temperatures in District Three are ranging between 11 and 19 degrees. District 3 has completed snow fighting operations. Areas of concern will be addressed by on call crews.

Engineering District 4 (Cherokee, Chester, Chesterfield, Fairfield, Lancaster, Union, and York Counties) – Temperatures in District Four are ranging between 7 and 17 degrees. Primary and Interstate routes are in good condition. Some isolated areas on secondary routes still have ice. On call crews are responding to requests from 911 and Highway Patrol. York and Union counties have returned to normal operations.

Engineering District 5 (Darlington, Dillon, Florence, Georgetown, Horry, Marion, Marlboro, and Williamsburg Counties) – Temperatures in District Five are ranging between 9 and 28 degrees. Priority routes and bridges continue to be treated with deicing materials and equipment, where temperatures allow.

Engineering District 6 (Beaufort, Berkeley, Charleston, Colleton, Dorchester, and Jasper Counties) – Temperatures in District Six are ranging between 21 and 30 degrees. The primary concern continues to be opening the Ravenel Bridge in the Charleston and returning it to good condition. Additional resources are currently assisting Charleston with their efforts. SC 170 (Alligator Alley) in Jasper County remains closed and rerouted due to ice on bridges in Georgia. Route conditions are reported as dry in Beaufort, Berkeley, Colleton, and Dorchester. Jasper is reporting wet conditions and Charleston reports some roads are still partially covered with ice. County crews are monitoring and treating routes, as necessary, with deicing materials and equipment.

The Ravenel Bridge in Charleston is still closed.

Next Steps:

1. **Governor's Authorization Needed:** By noon today, all county and state offices will be open, and all county EOCs will move to OPCON 5 (Note: Saluda County is not yet confirmed). With the Governor's confirmation, EMD would like to move the SEOC to OPCON 5 at noon today. In conjunction with that, we would like to issue an Executive Order effective at noon rescinding the State of Emergency.
2. **After Action Review** – EMD will be conducting a county AAR next week to go over the operations and work out any flaws. Kim Stenson will let us know the results of that review and if anything is needed.
3. **Cost Estimates** – Kim Stenson estimates that the cost of the operation will be around \$2.1 million for the State and, with county costs, most likely not above \$3 million. DOT spends roughly \$700k/day treating roads, and the National Guard spent about \$30k on equipment and manpower resources. As this cost estimate is way below any federal thresholds, these individual state agencies will be absorbing the costs.

Statewide Summary – Most roads have returned to dry (normal) condition, however some – (mostly secondary roads) are still covered with snow/ice. The forecast for this afternoon is sunshine and temperatures above the freezing mark statewide; this will accelerate de-icing efforts. Motorists are advised to use caution on all roadways, watch for snow, ice, and slow moving SCDOT maintenance vehicles. Crews in 4 of the 7 Engineering Districts have returned to normal operations. We anticipate the remaining Engineering Districts will return to normal operations by this afternoon. Statewide, all interstate routes are open and in fair or better condition. State Department of Transportation officials announced they are "hopeful" that the Arthur Ravenel Jr. Bridge will open before rush hour today.

The state is currently applying a saltwater solution with calcium chloride to speed up melting of the ice, according to Lee Floyd, state bridge maintenance engineer.

Floyd said this morning that the bridge was expected to open by early afternoon. A statement was later posted on SCDOT's website saying "We are hopeful that the bridge will be opened by rush hour today."

Officials told pedestrians and bikers to keep off the Ravenel Bridge because of the danger of icicles falling on them from the overhead cables.

Traffic out of Mount Pleasant was stop and go this morning as drivers were forced to use alternate routes. Drivers converged on Interstate 526 in masses, causing traffic congestion to spill onto the westbound lanes of Interstate 26.

Bacons Bridge Road is also closed between S.C. Highway 61 and Dorchester, S.C. Highway Patrol reports.

All other local bridges were opened late Wednesday.

Drivers are urged to use caution and expect delays.

For the first time in years Lowcountry residents have gotten to experience something that is routine in northern climes: salt on the roads and sidewalks.

But does it really work?

Yes, as long as it doesn't get too cold.

Anyone who has made homemade ice cream can see it work. Salt lowers the temperature at which water freezes. So by mixing salt and ice into a brine around the liquid ingredients for ice cream, which won't freeze at 32 degrees Fahrenheit, the temperature drops enough to freeze the ingredients into ice cream.

On roads it works the same way.

Water normally freezes at 32 degrees Fahrenheit. When salt is spread on roads in freezing conditions, it can prevent ice from forming, and can help melt existing ice. However, if it's too cold, the salt won't work. Generally salt is only effective at melting ice down to about 15 degrees F.

So why does salt work so well on roads but not bridges?

Because the bridges are exposed to the outside cold air from all sides, and roads are exposed only on the surface, allowing them to radiate heat longer. Also roads typically are paved with asphalt, which is not a good conductor of heat, meaning the heat stays in longer. Bridges typically are made of steel and concrete, both of which lose heat rapidly.

Cold to linger

Brisk temperatures are expected to linger throughout the Lowcountry over the course of the day, the National Weather Service reports.

Some effects of this week's winter storm remain.

Charleston officials warned of black ice on the peninsula on East Bay Street at the Cumberland and Queen Street intersections. Ice was also reported at the intersection of State and Broad streets.

Some areas may see an icy drizzle this morning with a slight chance of rain later this afternoon, according to the Weather Service.

Today's highs will be around 40 with lows around 30, the Weather Service reports. Winds will reach up to 15 mph.

Decisions to open and close the Ravenel Bridge are collaborative decisions made by law enforcement of the City of Charleston and the City of Mt. Pleasant upon recommendations made by SCDOT.

Yesterday, icicles could be seen from atop the bridge, which is why SCDOT recommended to the cities that pedestrian traffic not be allowed on the bridge when it reopened.

This is the first time the bridge has frozen in the nine years since it has been built, so SCDOT remains forthright in that there will be lessons learned from this event.

There is no timeframe for reopening. There are still several large chunks of ice falling off of the bridge. There is no easy way to get the icicles to thaw, and it is not recommended to put pressure on the cables in any way. There is hope that temperatures will stay warm enough overnight that the ice will not refreeze. Some icicles could be seen from eyelevel on the bridge yesterday, which is why DOT recommended to local law enforcement (City of Charleston and City of Mt. Pleasant) to prohibit pedestrian traffic. Again, it was a collaborative decision between the three groups to open/close the bridge. This is the first time the bridge has frozen in the nine years it has been built, so SCDOT is forthright in that there will be lessons learned from this event.

I. County / State Incidents

Laurens County - Search and Rescue (CONT')

At 08:12, The Laurens County Emergency Management Director reported they are still searching for the elderly 81 year old male, who has been missing since Wednesday night. Greenville ERT, Anderson County Horse Patrol, Union County, Abbeville County, and the South Carolina Civil Air Patrol (CAP), SLED, and DNR are assisting.

Charleston County – Bridge Closure

At 10:45, The State Warning Point was notified that officials in Charleston County are closing the Ravenel Bridge due to large chunks of ice falling from the cables onto the roadway. At 17:56, it was reported that the Ravenel Bridge has been reopened.

Georgetown County – Loss of Water Service

At 11:11, The Georgetown County Emergency Management Director received notification at 20:30 Thursday night that the Town of Andrews lost its water service after a break in the water line occurred. The School Superintendent closed Andrews' schools, and the elementary school was being used as a temporary shelter for students. As of 10:30 this morning, there were 50-100 students still at the school awaiting their parents' arrival. A temporary water tank and Port-a-Johns were deployed to the school. The County Director was informed by

Andrews Fire Department officials that it was a valve issue and Andrews and Georgetown County Water & Sewer Districts are working together to resolve the problem. The town administrator requested a CodeRed call-out notification be sent to residents of the town, advising them to boil the water for one minute until further notice.
