Mr. Kester,

It was a pleasure meeting with you this morning. Here is the revised quote for the work on your trees.

1. Trim 3 pecans from house to provide 10 - 12 feet of clearance. Haul away debris. The cost to do this is \$295.00.
2. Pecan, front right - Prune broke limbs and branch stubs 3" in diameter and larger. The cost to do this is \$90.00.
3. Pecan, back left - Prune broke limbs and branch stubs 3" in diameter and larger. Reduce one heavy leader that extends over yard by 20%. The cost to do this is \$135.00.
4. Pecan, back center - Prune broke limbs and branch stubs 3" in diameter and larger. Reduce one lower horizontal limb by 20%. The cost to do this is \$90.00.
5. Pecan, back right - Remove low limb growing into neighbor's leyland cypress. Prune broke limbs and branch stubs 3" in diameter and larger. Lighten limb growing towards other pecan. The cost to do this is \$135.00.
6. Grind 3 stumps, closest to A/C. Grind stump, front left corner of porch (near tea olive.) Grind large stump, front left corner of house. Grind holly stump, front left corner, near downspout. The cost to do this is \$200.00. Before we grind, we will contact SCPUPS for a utility locate.

Please let me know if you have any questions, or if you would like us to do this.
