Subject: Revenue and Fiscal Affairs Office and Executive Budget Office Recommended Legislation Changes

Frank:

The attached document contains some of our recommended conforming name changes to current statutes due to the reorganization mandated in Act 121 of 2014, the SC Restructuring Act. These recommended changes are to assist the Code Commissioner in his duty specified in Section 25 of the Act to update code references to reflect the creation of the Revenue and Fiscal Affairs Office and the Executive Budget Office. These changes also may impact the Executive Budget Office.

Most of the attached recommended changes are just transfers from the Budget and Control Board to the Revenue and Fiscal Affairs Office or the Executive Budget Office. Due to the close coordination and uncertainty between the responsibilities of the former Office of State Budget and the new Executive Budget Office, you may want the Governor's staff to review our recommendations.

A few recommendations are more substantial than just conforming name changes, and also affect the Executive

Budget Office. These recommendations have been included to apprise the Governor's staff on our recommend changes for these statutes. The substantial recommended changes are highlighted in the document.

Section 11-11-140(B) will require a policy decision as to who will monitor any accounting method changes in the Governor's annual budget recommendation to the General Assembly.

Any guidance we will give the Code Commissioner on the conforming name changes must be transmitted to him as soon as possible to meet the Act's July 1, 2014 deadline in Act 121.
