Dear Governor Haley:

During the second decade of the 21<sup>st</sup> century, state governments have made important and difficult choices in response to fiscal challenges, while meeting existing needs for public services. More than three quarters of American households are connected to the Internet, nine in 10 (92%) of American adults are mobile phone owners, and citizens and businesses are transitioning to self-service online government in growing numbers – at a time and place of their choosing.

To chronicle and formally recognize these efforts in service to the citizen, the Center for Digital Government through its Digital States Performance Institute conducts the Digital States Survey, the nation's original and only continuous survey of state government use of IT.

We look forward to your chief information officer and team participating with us as we explore and acknowledge IT innovations in state government. **The state's survey response is due June 15.** At the conclusion of the survey, responses will be compiled and each state will be assigned a grade. States with top grades will be honored at awards ceremonies throughout the country.

Additionally, all state grades are published and leading states will be profiled in *Governing* and *Government Technology* magazines. Similar to our past surveys, Digital States is expected to attract national coverage in major print and broadcast media, such as the *Wall Street Journal*, *USA Today* and *The New York Times*.

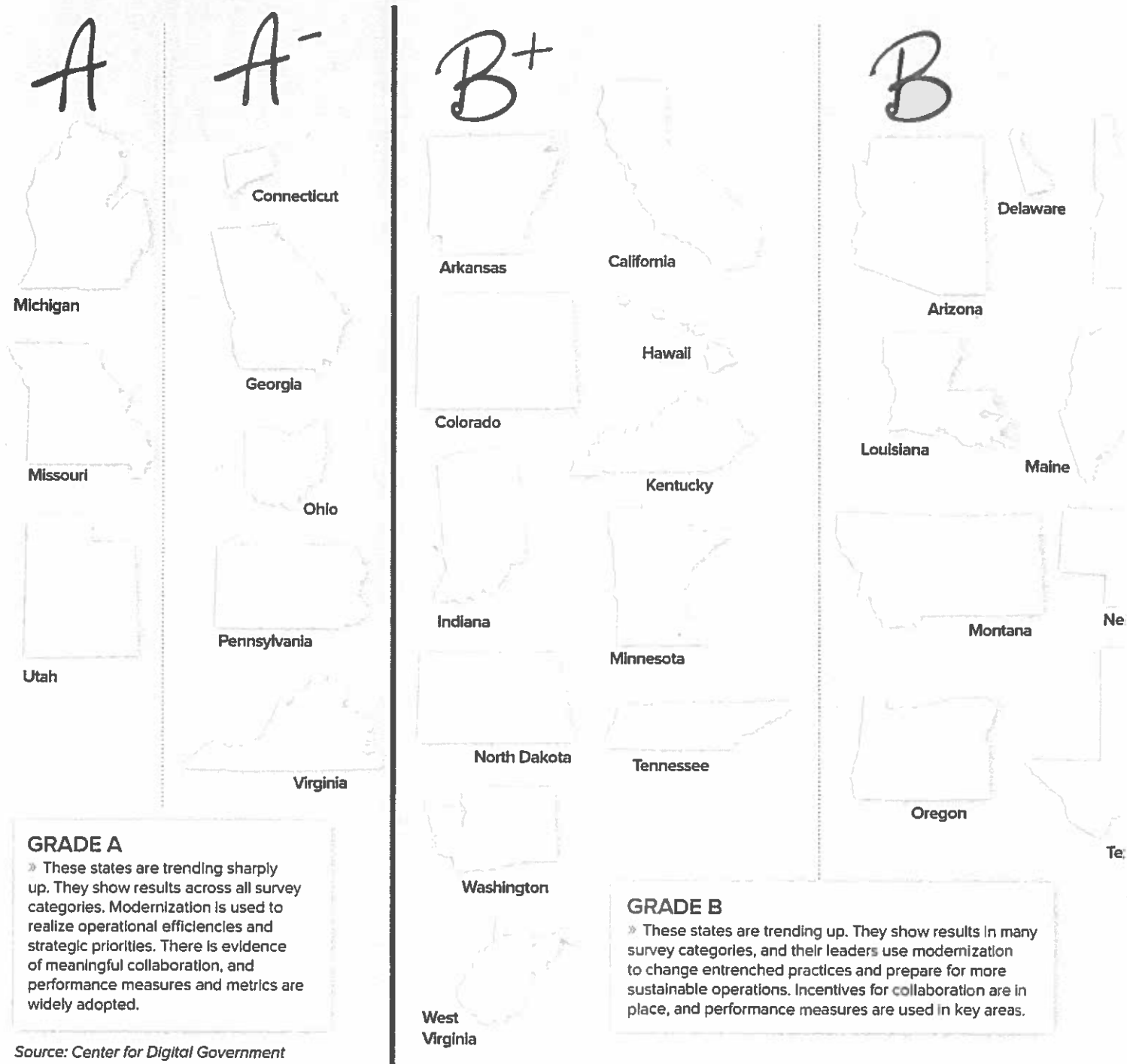

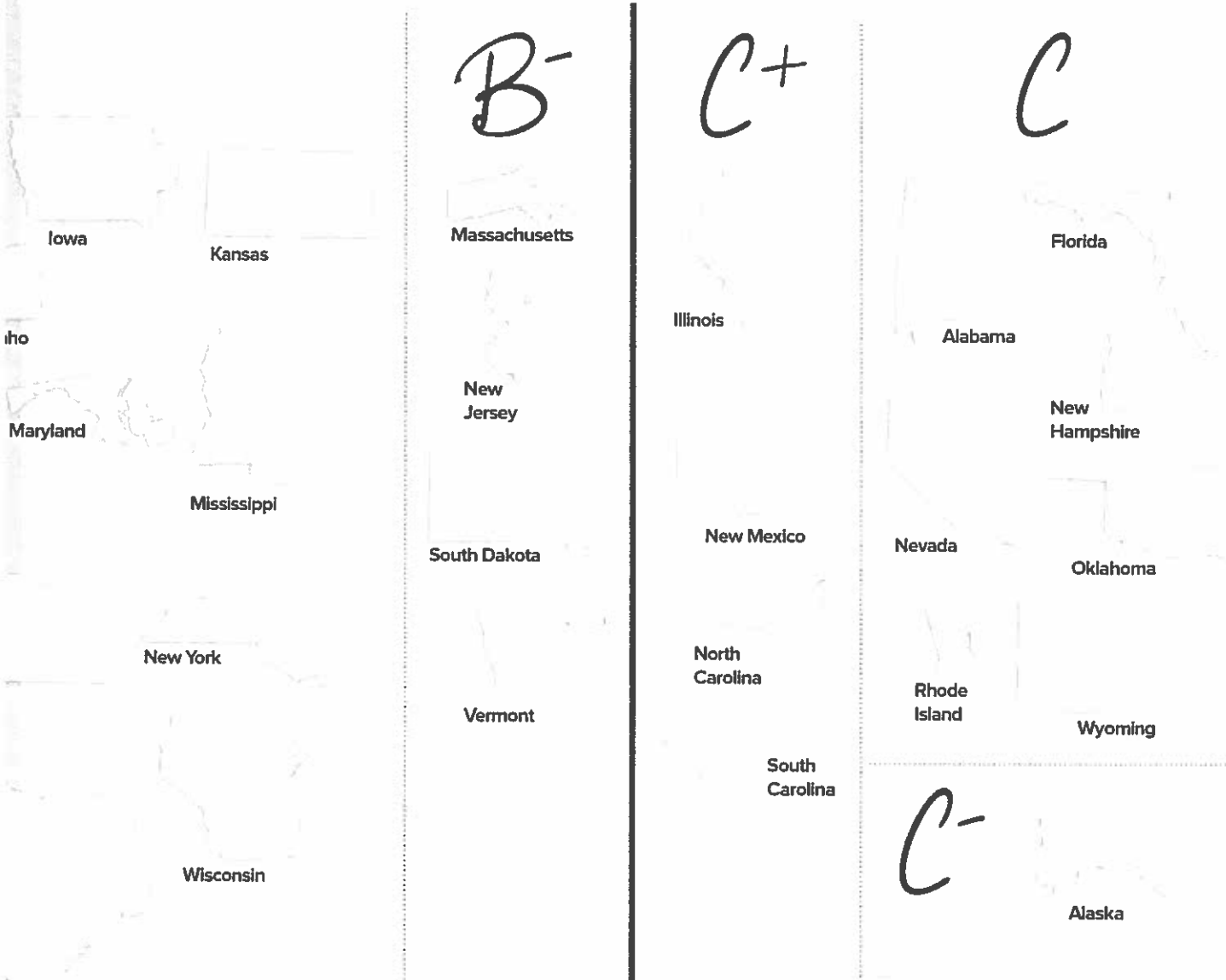
