**Greenville News:** SC sues feds over plan to halt \$30B MOX project

The state is suing the federal government over its plans to halt a \$30 billion project at the Savannah River Site to convert weapons-grade plutonium to commercial reactor fuel, arguing that suspending the project is unlawful and unconstitutional.

**Note:** "They messed with the wrong state," Haley said.

**Note:** "You've got millions of dollars invested in this facility," Haley said. "And suddenly you're going to say, 'Never mind, we didn't mean it, never mind, it was a bad idea?' You can't do that when it affects lives of people."

South Carolina sued the U.S. Department of Energy on Tuesday over the federal government's plans to scrap a plutonium recycling plant that has been under construction for years in the state, arguing it violates a nuclear non-proliferation treaty with Russia.

**Note:** "In South Carolina when I was raised by my parents, your word meant something," Haley said. "In Washington, D.C., that's no longer the case. Now we have a facility that D.C. started, and plutonium sitting there, and now you're going to stop MOX? We're not going to stand back and take it. They have messed with the wrong state."

"The governor's office is working with our cabinet agencies and the Division of State Information Technology as they continue to address any changes that need to be made."
