Had a good conversation with Ted. The tone of the meeting we had with the governor ten days ago on conservation issues was somewhat tense. I think she feels she doesn't have many allies that are conservationist. Most conservationist, however, are conservative. Sure, many on the front edge of environmentalism are liberals, but most that that hunt, fish, farm and enjoy the outdoors are conservative and value our environment.

The Conservation Land Bank is a great program for SC and a top priority of ours. Through it we have been able to set aside thousands of acres at an average cost of around \$650 per acre. We were disappointed that it was vetoed earlier this year. I understand from where the governor is coming, but ask that it be taken into consideration that PRT, DNR and the Dept of Ag. comprise less than 1% of the state budget combined. DNR's general fund budget has been cut 50% in recent years and the CLB is run on a shoestring.

Yes, jobs and low taxes are important. However, you come from the hospitality industry, so you understand that the natural resources of this state are an important factor in getting people to settle here. I don't think that pro-business and pre-conservation agendas have to be mutually exclusive. Just my opinion, but also wanted to let you know that I would be happy to serve as a conduit between environmental groups like Conservation Voters and your office.
