

In November, Medicaid benefits were denied due to the fact certain requirements were not met. After receiving a diagnosis of schizoaffective disorder with overlapping attention deficit disorder, medically necessary services such as drug and cognitive-behavioral therapy are vital for positive treatment. These elevated costs stand beyond the boundaries of my earned \$2,500 in 2008 due to an eight month stay at the National Institute of Mental Health schizophrenia research unit.

After contacting M. Roberts (Worker) at the Department of Health and Human Services at 803.785.2930 multiple times and leaving numerous messages, I have never received a returned phone call. I feel that an entity from Sen. Lindsay Graham's office would be more triumphant in reaching M. Roberts. If you would please call and have her call me at 803.269.1276 that would ideal. Dear Mr. Hinrichs:

Senator Lindsey Graham contacted our agency on your behalf regarding your concerns about Medicaid eligibility and problems you faced when trying to reach a Medicaid eligibility worker.

Good customer service is very important to us, and I regret your unpleasant experience during our eligibility determination process. We are reviewing the issues you have encountered, and we are working to correct them.

Your application for Medicaid's Aged, Blind or Disabled (ABD) program was denied on December 1, 2008 because you do not meet the Social Security Administration's (SSA) disability criteria. Medicaid is required to adopt SSA's decision when determining eligibility for the ABD program.

You are currently appealing SSA's decision. If you would like to check the status of your appeal, please contact the Columbia SSA Office of Adjudication and Review at (803) 929-7635. If SSA reverses its decision, you should contact the Richland County Medicaid Office at (803) 714-7561 to see if you will then qualify for ABD.

Enclosed is information on other programs and organizations that can assist residents in South Carolina with their healthcare needs, prescriptions and inpatient hospitalization. If you have other questions about the Medicaid program, please contact Ms. Jennifer Lynch in Constituent Services at (803) 898-3965 and she will be happy to assist you. We hope this information is helpful.
