SECTION 1: The Minutes for the meeting of October 18, 1990; copies of which have been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion accepting montly reports as published by the Department of activities for the month of October, 1990.



SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$1,000.00 during the month of October, 1990, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the action of the Department in entering into a contract with Ralph Whitehead and Associates to provide preliminary engineering services for a bridge structure in Laurens County, at a cost of \$133,265.00, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to enter into a supplemental agreement with Baker Engineers for additional engineering services for upgrading a section of I-85 in Cherokee County at an estimated cost of \$1,571,000.00, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement numbers 4 and 5 with CRS Sirrine, Inc. for additional engineering services for the Pelham Road widening project in Greenville County at a cost of \$71,000.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to enter into a supplemental agreement with Ralph Whitehead and Associates for additional services on the Dawhoo River Bridge Replacement in Charleston County at a cost of \$85,677, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion awarding an additional \$43,181.69 in reserve State General Funds to assist the Consolidated Area Transportation Authority in York County in meeting debt obligations.

SALE OF SURPLUS RIGHT OF WAY PROPERTY - LAND
