Arkansas Proposes Big Change to Higher Education Funding

On July 29, Gov. Asa Hutchinson of Arkansas unveiled a new performance-based funding model for higher education that will go before the Legislature in 2017. Most states have some element of performance incorporated into funding formulas. If the proposal is passed, Arkansas would become the fifth state to have a funding formula based exclusively on outcomes.

State Jobs Report: May 2016

In May 2016, most states--44--saw nonfarm payroll employment grow over the previous year. Employment in five states--Florida, Idaho, Oregon, Utah and Washington--grew by more than 3 percent. In six states--Alaska, Kansas, Louisiana, North Dakota, Oklahoma and Wyoming--year-over-year employment declined. Across all states and the District of Columbia, employment grew by 2.4 million, or 1.7 percent, from May 2015 to May 2016.

Women in State Government, 2016

With Hillary Clinton as the first female presidential nominee from a major party, it is noteworthy that women are still underrepresented in state government leadership positions. In 2016, women make up less than one-quarter of state legislators and statewide elected executive officers, and less than one-third of all state court judges. Only the number of female state judges has seen significant increases in recent years.

Coloradans Will Battle for Environmental Issues in November

Since April, environmental groups in Colorado have been working to gather signatures for two statewide initiatives that would amend the state constitution to increase regulatory control on energy industries. Coloradans Resisting Extreme Energy Development submitted two measures, Initiatives 75 and 78, that would grant local governments the authority to regulate energy industry development and establish that facilities be at least 2,500 feet from an occupied structure.


