


Letters to all Governors in America

TO THE GOVERNOR OF *South Carolina,*

ENCLOSED ARE A COPY OF THE FREE PRESS OF USA(fpousa) TO GETHER WITH A COPY OF ITS IST PRESS RELEASE. IN BEHALF OF THE PEOPLE IN YOUR STATE, WE REQUEST THAT YOU OBEY THE REQUIRED OATHS OF YOUR OFFICE TO SUPPORT AND DEFEND THE CONSTITUTION OF THE UNITED STATES AND OF YOUR STATE, NOT IN CONFLICT THEREWITH, AND FAITHFULLY PERFORM THE DUTIES OF YOUR OFFICE.

STATE SUPPORTED LAW SCHOOLS AND OTHER ACCREDITED LAW SCHOOLS IN MOST STATES ARE FOLLOWING THE LEAD OF HARVARD AND YALE IN TEACHING THE FEDERAL RULES OF CIVIL PROCEDURE (FRCP) ARE THE SUPREME LAW OF THE LAND. THESE RULES ADOPTED IN MOST STATES, GIVE FEDERAL AND STATE JUDGES POWER TO DISMISS ANY CASE THEY CHOSE WITH PREJUDICE.

GO TO THE LIBRARY. DOCUMENTS 1-6 ARE WHERE THE FEDERAL DISTRICT COURT IN CHARLOTTE, NC AND THE 4TH CIRCUIT COURT OF APPEALS ILLEGALLY DISMISSED CASES SEEKING TO ENFORCE TRIAL BY JURY.

THE REMAINING DOCUMENTS CONTAIN EVIDENCE OF NC COURTS AT EVERY LEVEL ILLEGALLY DISMISSED THEM USING ILLEGAL RULES DESPITE ART IV, SEC 13 OF THE NC CONSTITUTION EXPRESSLEY FORBIDS THEIR USE.
