

MEMORANDUM OF AGREEMENT

BETWEEN

UNIVERSITY OF SOUTH CAROLINA

AND

STATE BOARD FOR TECHNICAL AND COMPREHENSIVE EDUCATION

On December 4, 1975 the South Carolina Commission on Higher Education approved the recommendation of its Committee on Academic Program Development that action on proposals to establish Criminal Justice Programs (Associate in Public Service Degree) at Sumter Area Technical College and Beaufort Technical Education Center be deferred until local cooperative agreements are developed between the respective technical institutions and USC regional campuses in Sumter and Beaufort.

Subsequent to this action, the chief administrators of the institutions involved met unilaterally and together with the Associate Vice President for USC regional campuses and TEC's Director of Educational Services to develop agreements whereby duplication of course offerings would be minimized or eliminated.

It was therefore agreed that:

1. The chief administrators and their staffs will formally meet prior to each quarter/semester to analyze course offerings and anticipated student enrollment to determine which institution should offer the courses in question.
2. Students will be cross-enrolled in a transient student category and academic records will be maintained at both cooperating institutions.
3. No fees will be paid by TEC students to USC or by USC students to TEC. USC will bill TEC at the adjusted quarter hour rate charged by TEC and TEC will bill USC at the adjusted quarter hour rate charged by TEC.
4. FTE's will be reported by the institution teaching the courses.
5. One year from the date of Commission on Higher Education approval this agreement will be reviewed by the institutions involved, the Associate Vice President for USC regional campuses and TEC's Director of Educational Services. A report of the review will be submitted to the Executive Director of the South Carolina Commission on Higher Education.
6. The initial group of courses to be offered to the TEC Criminal Justice students by the regional campuses are listed below. It should be noted that the courses in the general education area requested to be offered by the USC regional campuses will vary at each locale due to the fact that the individual TEC institutions determine the general education

and elective courses in its Criminal Justice program. Only the specialty courses in the major are proscribed by the TEC model curriculum.


