Dear Marion,

Thanks very much for your kind letter of September 12, 2006. We'll get going on Shirley!

Let me bring another case to your attention. Kathleen A. Schipper, Medicaid SC #2780386324, is an unfortunate 40 year old Type I diabetic, already a left BK amputee, with an open non-healing ulcer on her right foot.

We are working through the National Healing Wound Center which is now associated with Georgetown Hospital System. We have the capability of hyperbaric oxygen, and Kathleen desperately needs to be treated here. It would be terrible to see her 41 and a double amputee, and it would also be a significant drain on SC Medicaid. Is there any way we can get a waiver to treat this patient? Currently South Carolina Medicaid does not fund hyperbaric treatments.

We have a rigid protocol for hyperbaric candidacy. And after 20 treatments, we must document significant wound improvement, before hyperbaric therapy is continued.

Several other Medicaid recipients in our area are candidates for hyperbaric treatment. This therapy is available in many states' Medicaid systems. May we visit, or revisit, the possibility of South Carolina Medicaid funding appropriate hyperbaric therapy?

Dear Mason,

Thank you for corresponding regarding Ms. Schipper. I have not had any recent experience with reviewing request for payment relating to hyperbaric therapy. I will review this with the appropriate professional staff at DHHS and we will be getting back with you. I am uncertain of their current policy or the ability for a medical consultant such as me to allow deviations from existing policy or guidelines. I will certainly make every effort to find a solution.

If there is current South Carolina Medicaid policy relating to payment approvals for hyperbaric therapy, we just need to make certain that this particular patient fits those criteria. From the content of your letter, I think that she will be a good candidate for this treatment. If current SC Medicaid policy does not allow for hyperbaric oxygen therapy, I will inquire as to whether an exception to policy is allowed in these circumstances for medical necessity. In either case I will get back to you with more specifics.

I hope that we will be able to see you in the not too distant future. Tell Rita hello for us.
