Furthermore, the matter appears to have been disposed with finality by the ALC, and therefore, our office would usually advise a constituent to seek the advice of private legal counsel. If it was a simple SHP matter, then the Ombudsman might be able to help, but it appears as though this issue has run through the system and is closed.
