Ladies and Gentlemen:

Speaker Harrell has asked me to inquire of the membership as to whether 2:00 p.m., Wednesday, August 27, 2014, would be a convenient date to wrap up several matters which were not addressed by the House prior to adjourning in June.

As you may remember, several issues were pending in the Senate when the House adjourned on June 17. These items include the Governor's vetoes of R. 314 (S. 813 – concerning removal of persons from public libraries) and R. 205 (S. 293 – concerning the levy and addition of millage for Murrell's Inlet-Garden City Fire District) which the Senate considered and voted to override after the House adjourned on June 17.

A PDF copy of the Governor's veto messages is attached to this e-mail for your review.

At this time the House is anticipating meeting at 2:00 p.m., Wednesday, August 27, 2014, to complete these final matters from the 2014 session. It is anticipated that work will be completed in one day.

We know that there is NO date that will be convenient for all House members. However, it is important that the House meet one day to complete these outstanding issues.
