SECTION 1: The Minutes for the meeting of June 2, 2000; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving the sale of surplus right of way property - land, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion accepting the draft 2001-2005 State Transportation Improvement Program (STIP) and authorizing the Department to submit the STIP for public comment.

SECTION 4: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in extending existing bituminous retreatment contracts to include additional resurfacing work, as shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion rescinding its action adding a section of road to the State Highway System, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in removing sections of roads from the State Highway System, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion adding sections of roads to the State Highway System, as shown in detail in the Appendix.

SECTION 9: On motion of Commissioner Stoddard, seconded by Commissioner Hardee, the Commission unanimously passed a motion approving the request of the Anderson County Legislative Delegation naming the additional portion of State Highway 86 in Anderson County from the intersection of State Highways 53 and 86 to the intersection of Highway 17 and State Highway 86 as the "M. J. "Dolly" Cooper Highway".

SECTION 10: On motion of Commissioner Stoddard, seconded by Commissioner Truluck, the Commission unanimously passed a motion adopting a resolution naming the intersection of South Carolina Highway 63 and South Carolina Highway 205 near Belton as the "Fullbright Crossroads", as shown in detail in the Appendix.

SECTION 11: On motion of Commissioner Stoddard, seconded by Commissioner Hardee, the Commission unanimously passed a motion adopting the following Concurrent Resolutions, copies of which are shown in the Appendix.

SURPLUS RIGHT OF WAY PROPERTY - LAND

1. File 39.674 - US Route 123 - Pickens County

During Right-of-Way acquisition for improvements on SC Route 123, under File 39.674 in Pickens County, near the City of Clemson, the Department acquired right-of-way for SC Route 123, by Title to Real Estate from Howard Barefoot .

The Department acquired the frontage from the subject parcel and installed a new control of access which landlocked the property and left the existing business with no access. To settle the acquisition and avoid displacing the business it was agreed that the business would buy adjacent land for its access and the Department would sell the subject parcel for \$9,850.00. Therefore, a Quitclaim Deed for approximately 0.7 of an acre of land to **Seyed M. Mahini** in consideration of \$9,850.00 was executed on May 3, 2000.

2. File 32.316 - Road S-22 - Lexington County

During construction of improvements on Road S-288, under File 32.316 in Lexington County, near the Town of Swansea, the Department acquired right of way, by Deed to Right-of-Way from M. S. Culclasure dated October 19, 1951.

A request was received from the adjacent property owner to purchase a small parcel of right-of-way when the above project was completed. The right-of-way is located on what is now a portion of abandoned Road S-288. The request was circulated to the Engineering Sections who determined that the subject parcel was surplus to the Departments needs. Therefore, a Quitclaim Deed for approximately 0.126 of an acre of land to was executed to **Ricky & Deeann Richardson** on May 4, 2000 in consideration of \$1,000.00.

3. File 23.276A - SC Route 418 Relocation - Greenville County

During construction of improvements on SC Route 418 Relocation, under File 23.276A in Greenville County, near the Town of Fountain Inn, the Department acquired right of way, by Notice of Condemnation from Charles L. & Margaret Alberson dated October 12, 1998.

During negotiations by the Legal Department to acquire right of way for SC Route 418 relocation the Department filed a condemnation notice attempting to acquire 1.09 acres for new right of way. The condemnation trial awarded the Department only 0.86 acres (resulting in a difference of 0.23 acres in the Notice of Condemnation and the court's ruling). In order to return the Departments interest acquired under the Notice of Condemnation, a Gratis Quitclaim Deed for approximately 0.23 acres of land to **Charles L. and Margaret Alberson** was executed on May 4, 2000.

4. **File 40.127A - Road S-1486 - Richland County**

During construction of improvements on Road S-1486, under File 40.127A in Richland County, in the City of Columbia, the Department acquired right-of-way, by dedication from the City of Columbia dated January 6, 1960 and by Easement from the South Carolina Department of Mental Health dated March 3, 1981.

The City of Columbia is receiving a deed on the adjacent eight-acre tract from the South Carolina State Budget and Control Board. A small triangular portion of this tract comprises a 0.50 acre portion of old abandoned right-of-way, which was originally received by the Department from the City of Columbia. It is necessary for the Department to Quitclaim its interest on this old right-of-way in order for the City to gain a clear title. Therefore, a Gratis Quitclaim Deed for 0.5 of an acre of land to **The City of Columbia** was executed on May 4, 2000.

5. **File 40.485 - Road S-869 - Richland County**

During construction of improvements on Road S-869, under File 40.485 in Richland County, near the City of Columbia, the Department acquired right-of-way, by Right-of-way Easement from Eastminister Presbyterian Church dated June 30, 1958.

A request was received from the adjacent property owner asking to acquire a small parcel of right-of-way. Originally a 30' right-of-way was secured Gratis from Eastminister Presbyterian Church for improvements on Road S-869. No improvements were ever constructed. This request was circulated to the Engineering Section who determined that it was surplus to the Departments needs therefore, a Gratis Quitclaim Deed for approximately 0.29 of an acre of land was executed to **Eastminister Presbyterian Church** on May 22, 2000.

6. **File 20.472 -Road S-34 - Fairfield County**

During construction of improvements on Road S-34, under File 20.472 in Fairfield County, near the Town of Rockton, the Department acquired right-of-way, by Notice of Condemnation from Rebecca V. L. Ellison, Life Estate dated November 17, 1986.

A request from the adjacent owner to acquire a small parcel of abandoned right-of-way was received. The request was circulated to the Engineering Sections who determined that the said parcel was surplus to the Departments needs therefore, a Gratis Quitclaim Deed for approximately 0.41 of an acre of land was executed to the **South Carolina Railroad Museum** on May 24, 2000.

7. **File 4.994 - Road S-331 - Anderson County**

During construction of improvements on Road S-331, under File 4.994 in Anderson County, near the Town of Centerville, the Department acquired right of way, by Title to Real Estate from Margaret Gallant Sullian dated December 22, 1965.

During negotiations, by the Legal Department to acquire right of way and settle a condemnation case, it was agreed that a nearby surplus tract adjacent to John C. Pracht's property, acquired as described above, would be deeded to him upon completion of the project. Therefore, a Gratis Quitclaim Deed for approximately 0.17 of an acre of land was executed to **John C. Pracht** on May 23, 2000.

8. **File 37.495 - SC Route 130 - Oconee County**

During construction of improvements on SC Route 130, under file 37.495 in Oconee County, near the Town of Seneca, the Department acquired right of way, by Easement from Crescent Resources Inc. dated August 8, 1967.

The adjacent property owner requested to purchase a portion of abandoned Road S-38. Crescent Resources provided the new right of way and constructed the Relocated Road S-38. It was agreed that the Department would convey the Old Abandoned Road S-38 to them in consideration for the new right of way that was provided. Therefore, a Gratis Quitclaim Deed for approximately 0.65 of an acre of land was executed to **Crescent Resources, Inc.** on May 30, 2000.

This matter is reported to the Commission in accordance with the requirements of Code Section 57-5-340.

EXTENSION OF CONSTRUCTION CONTRACTS

It is recommended that the Commission approve the action of the Department in extending existing construction contracts to include additional work, as follows:

GREENWOOD COUNTY:

Contract of Satterfield Construction Company, Inc. - File 24.80991 - extended to include removal (File No. 24.80991) of existing pavement, pavement markings, drainage, construction of concrete sidewalk, curb and gutter on SC 252.

Estimated Cost of Extension \$130,468.90

HORRY COUNTY:

Contract of Palmetto Paving Corporation - File No. 26.80991- extended to include resurfacing (File No. 26.80991) and pavement markings on S-808 for 1.75 miles.

Estimated Cost of Extension \$ 85,398.47

Contract of APAC-Carolina, Inc. - File No. 26.996.1 - extended to include grading, drainage, resurfacing and asphalt concrete surfacing, and pavement markings (File No. 26.996.1) on S-1129 at US 501.

Estimated Cost of Extension \$ 58,197.63

MARION COUNTY:

Contract of APAC-Carolina, Inc. - File No. 34.569 - extended to include erecting steel beam guardrail (File No. 34.569) on US 76 at the Pee Dee Academy School.

Estimated Cost of Extension \$ 5,414.93

NEWBERRY COUNTY:

Contract of Satterfield Construction Company, Inc. – File No. 36.80991 – extended to include resurfacing (File No. 36.80991) with asphalt concrete surfacing on S-489 for a total of 0.13 mile.

Estimated Cost of Extension \$ 5,028.48

SALUDA COUNTY:

Contract of Satterfield Construction Company, Inc. – File No. 41.80993 – extended to include resurfacing (File No. 41.10991) with asphalt concrete surfacing on S-176, S-65 and S-12 for a total of 3.48 miles.

Estimated Cost of Extension \$ 91,500.15

These extensions were authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

Estimated Cost of Extension \$ 19,436.84

LEXINGTON COUNTY:

Contract of Lanier Construction Company, Inc. - File 32.10001 - extended to include resurfacing (File No. 32.10001) with asphalt concrete surfacing on US 321 and West Campus Drive at Wil Lou Gray Opportunity School.

Estimated Cost of Extension \$ 37,039.08

AGREEMENT

This Agreement made by and between the South Carolina Department of Transportation (SCDOT) and the South Carolina Transportation Infrastructure Bank (SCTIB) this ____ day of _____, 2000.

WITNESSETH

WHEREAS, pursuant to an Intergovernmental Agreement by and between the SCDOT and the SCTIB, dated March 10, 1998, the SCDOT agreed to pay the SCTIB \$114,000,000 payable in eleven annual installments each of \$10,000,000, and one payment in the twelfth year of \$4,000,000, commencing in 1998, for the initial phase of the Conway Bypass; and

WHEREAS, pursuant to Intergovernmental Agreements by and between the SCDOT and the SCTIB, dated April 27, 1999 and May 7, 1999, the SCDOT agreed to pay the SCTIB \$7,600,000 annually for twenty years commencing July 1, 1999, for Phase II of the Conway Bypass; and

WHEREAS, for purposes of this Agreement, the Intergovernmental Agreements described in the first and second whereas clauses are referred to herein as the "Intergovernmental Agreements"; and

WHEREAS, the SCTIB has issued, and intends to issue in the future, revenue bonds, the repayment of which may not be from revenues that involve any tax within the meaning of Article X, Section 13 of the South Carolina Constitution; and

WHEREAS, the SCTIB has requested that the SCDOT make such payments from revenues that do not involve any such tax.

NOW THEREFORE, SCDOT hereby agrees as follows:

1. SCDOT has complied with all requirements in order for the SCDOT to be eligible to receive certain federal funds, including, without limitation, funds received by or on behalf of SCDOT pursuant to Chapter 1 of Title 23, United States Code, as amended and supplemented from time to time and any successor or replacement provision of law (hereinafter referred to as Federal Highway Reimbursement Funds).

2. SCDOT will during the term of this Agreement use its best efforts to continue to comply with all requirements in order for the SCDOT to continue to be eligible for Federal Highway Reimbursement Funds.

3. SCDOT will, to the extent Federal Highway Reimbursement Funds are available, make payments to the SCTIB pursuant to the Intergovernmental Agreements from monies SCDOT receives from Federal Highway Reimbursement Funds. SCDOT represents and warrants that:

i. it is authorized, has all necessary power and authority, and has the lawful right to make payments to the SCTIB pursuant to the Intergovernmental Agreements from Federal Highway Reimbursement Funds,

ii. the Federal Highway Reimbursement Funds sufficient to pay 1.20 times SCDOT's obligations to the SCTIB are not pledged for the payment of any other obligation of the SCDOT or any other entity,

iii. it will not create any priority of assignment or security interest in the Federal Highway Reimbursement Funds that is senior or superior to the obligation to make payments to the SCTIB pursuant to the Intergovernmental Agreements, and

iv. in the event, in the future, SCDOT obligates Federal Highway Reimbursement Funds to be paid on a parity with SCDOT's obligations under the Intergovernmental Agreements, SCDOT will ensure that such Federal Highway Reimbursement Funds will have 1.20 times historical coverage of the sum of the annual payments under the Intergovernmental Agreements and every such parity obligation.

5. SCDOT will, in the event Federal Highway Reimbursement Funds are not available to SCDOT to make annual payments under the Intergovernmental Agreements, use its best efforts to make such payments to the SCTIB from monies which do not involve any tax within the meaning of Article X, Section 13 of the South Carolina Constitution. SCDOT will discuss its proposed source of payments with the SCTIB's bond counsel prior to making such payment from monies other than Federal Highway Reimbursement Funds.

6. The term of this Agreement shall begin upon its execution by the appropriate officials of the SCDOT and the SCTIB and will expire on the date the last payment on the Intergovernmental Agreements is made by the SCDOT to the SCTIB.
