

Dear Governor Haley,

Enclosed please find our letter sent on August 26 to your office asking information (additionally according to FOIA) about your actions: done, pending or planning to be done in the SCANA (NYSE:SCG) / SCE&G - ORS - PSC mega-scandal, which is harming financially our state and its people.

Collecting money from SCE&G 702,000 ratepayers is illegal because of false claimed assumption of Base Load Review Act (FCA of BLRA) for non-base load plant in Jenkinsville. SC regulatory and judicial systems should have the first lesson from Enron (NYSE:ENE) scandal 2001-2006 and the second lesson from the elementary physics that were ignored by ORS/PSC since 2008.

It is high risk that Nuclear Renaissance could be hurt by ignoring Bush-Obama stimulus, which is used e.g. by twin project in Georgia (at least \$8.3 Billion). The Jenkinsville project is already three years behind its schedule and also behind China Sanmen project with same AP 1000 reactors. The SCANA scandal has international scale via NY Stock Exchange. ("Wall Street").





Dear Governor Haley,

We have written to you before and at this time we are requesting information concerning the South Carolina Electric and Gas rate increases. SCE&G is again requesting a large increase in rates, forcing the customers to pay, yet again, for the nuclear plants construction and all other expenses related to them.

What we are asking of your office is information concerning what your office has done, or is planning to do in this case. We do not see that the Public Service Commission is representing the public in any way. Every request for more money from the customers has been granted in spite of protests and proof that the PSC should not do so.
