***King v. Burwell* Oral Arguments Begin Tomorrow**

NASHP today released a [statement](#) from Trish Riley, Executive Director, on the Supreme Court case and the implications for states. "*King's* challenge to whether the Affordable Care Act's premium subsidies can be made available in states with exchanges run by the federal government could have significant implications, as many as eight million Americans may be affected by the outcome. Nearly 1,000 Participants Tuned in to Learn More About the Community Health Workers Model

Hundreds of health policy leaders joined our [webinar](#) last month on community health workers or CHWs. As states transform their health systems, many are turning to CHWs to tackle some of the most challenging aspects of health improvement, such as facilitating care coordination, enhancing access to community-based services, and addressing social determinants of health. As interest in CHWs continues to rise, so do challenges related to defining roles and scope of practice, training and certification, financing, and integrating CHWs into evolving health care systems. This [webinar](#) described the federal government's investment in CHWs and featured speakers from state agencies in Massachusetts, New Mexico, and South Carolina. The Affordable Care Act (ACA) makes health insurance coverage more affordable for many Americans by providing federal premium tax credits to eligible individuals. To help make this coverage more affordable for everyone purchasing through marketplaces, the ACA requires all Americans purchase coverage or pay a penalty. The 2014 tax season will be the first year these new requirements apply.
