Dear Mayor Camp,

I am writing to you, concerning Chester County Natural Gas Authority board member and Town of Great Falls appointee Nancy G. Carpenter. Mrs. Carpenter has served on Chester County Natural Gas's Board of Directors since May 2005. She was appointed by the Town of Great Falls to complete her husband, Don Carpenter's 6 year term. That term ended June 17, 2010 and she is currently on hold over status until reappointed or a replacement is appointed. Mrs. Carpenter is now the 3<sup>rd</sup> longest serving member on the Gas Authority's 5 member board and has expressed her willingness to continue to serve as the Town of Great Falls representative on the Chester County Natural Gas Authority Board of Directors.

ACT NO. 527 (Amendment to Chester County Natural Gas Enabling Act) of the Acts of South Carolina for 1957 provides in part as follows:

Section 3. The Authority shall consist of a board of five members appointed by the Governor, two on the recommendation of the City Council of the City of Chester, one upon the recommendation of the Great Falls Public Service Commission (now the Town Council of the Town of Great Falls) and two upon the recommendation of the Senator and one-half of the members of the House from the County at large. .... Hereafter, all terms shall be for six (6) years and until their successors are appointed and qualify.

The natural gas industry is a changing and complex industry. The education process of a board member at Chester County Natural Gas is anywhere from 6-8 years. If a board member desires to continue to serve, and is active in their role as a Gas Authority board member, we want that person stay on our board as long as possible because of that lengthy educational process in a complex industry.

During this time of uncertainty in the energy industry, we must maintain an atmosphere of continuity, leadership, and experience on the Board of Directors as Chester County Natural Gas moves into this period of the energy industry. There are difficult issues ahead that could affect

Chester County Natural Gas for many years and decisions must be made with current and historical knowledge of the natural gas industry.

On behalf of the Chester County Natural Gas Authority Board of Directors, we would like to request that the Town of Great Falls recommend Mrs. Nancy G. Carpenter to the Governor's office to be re-appointed to a full six year term that would have begun on June 17, 2010, and will expire on June 17, 2016.
