M I N U T E S

PRESENT: Vice-Chairman - Daniel A. Rhodes

Mr. Rhodes called the meeting to order and Councilman Bratcher gave the invocation. Mr. Poore was still in the hospital and unable to attend.

On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to approve the minutes of the September 21, 1982 meeting as mailed.

Mr. Charles Whiten, Public Defender, requested office space in the new office building on the third floor. This would be the unfinished space across from the Purchasing Office. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to allow the Public Defender the office space he requested.

Mr. Pat Flack asked Council if any money and space was available for the Human Resources Commission. He stated he could use the space that the Delegation will be moving out of. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to transfer the balance of \$5,637.92 from account # 310.84 (RS) to the Human Resources Commission's budget.

Mr. Flack also asked approval on changes in the commissioner and advisory boards. Mrs. Marie Collins to replace Mr. Fred Gentile, Mr. H.J. Mackey to be replaced by Mr. Marvin Mattison and Mr. Robert Gallant to be replaced by Dr. Charles E. Waller. On the motion of Mr. Bratcher, seconded by Mr. Kinley, Council voted unanimously to replace the members as requested by Mr. Flack.

Mr. David Watson asked that Council approve \$25,000 for patching for the month of October. After some discussion, Council directed the Purchasing Agent to find out where the money came from to repair a road near Broadway School Road around Pine Forest Subdivision. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to hold a called meeting Thursday, October 6, 1982 at 6:00 to discuss road patching and at which time the Council Engineer will submit a list of all roads that are being patched.

Mr. Watson asked Council for funds for temporary help in the Purchasing Office. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to transfer \$500 from account 111.85 to 111.01 for this temporary help.

Mr. Watson discussed bids for courthouse furniture. He stated that the total amount needed for this furniture would be \$20,975.14 from the Bailes Bond. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to purchase from the vendors as Mr. Watson recommended.

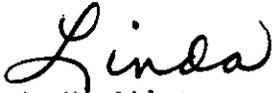
Mr. Hooper presented second reading of ORDINANCE #96 (Magistrate's Office). On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted two in favor and one opposed. Mr. Bratcher opposed the motion.

Mr. Kinley read a sealed proposal form stating that the County will accept proposals until 11:00 a.m. October 13, 1982 for rental of certain farm properties located near the County Stockade. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted two in favor and one opposed the proposal. Mr. Bratcher voted against the motion.

Mr. Hooper read a request from Barney Darby, Co-Chairman for the Broadway Lake Improvement Service Society requesting that Carlisle Thompson, Hale Sherrard, Marshall Hill, Cole Sutton, Fred Stringer and Dick Allen be appointed to the Commission for a four year term. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to appoint these people as requested.

Council adjourned at 9:35 a.m.
