My name is mr. Goldstein David Scott I am currently at corrective care in Columbia South Carolina and I need a response to this email immediately please and I need it read very thoroughly thank you for your time and consideration

Good afternoon today is Sunday today I write this email involving the govern

or of the state of South Carolina and involving the governor of the state of South Dakota on February 21st I wish detainer 4 tuberculosis the hospital in South Dakota had me in a room that was guarded by the

US Marshals because it was a federal quarantine required by CDC upon proper testing from the hospital I have had X-rays done my blood has been tested smears have been taken and a cat skin has been done all too come with the conclusion but everything is negative now I sit being it illegally detain without a federal court order only a order from the CDC

I do not have do not do not do not have tuberculosis and I need representatives from Congress the governor of South Dakota the governor of South Carolina

to get involved and to intervene and to issue my release

I am being held corrective care which is a health facility that is for convicted inmates I am not a convicted inmate I am only being held on a detainer and under the US Constitution I shouldn't be held with convicted felons in a confinement that is for locked down people that have already been convicted of crimes this is a u.s. constitutional violation of my rights

also I was told by CDC all my rights would be adhered to I could order pizza I can order takeaway I can use my phone when I choose to none of these rights have been exercised I can smoke cigarettes and a smoking area that will be provided for me

that has not been done I have been put on a diabetic diet against my will when I came in here I said I did not want to be treated for diabetes they have given me insulin they have given me medication malpractice is the answer

8 units of insulin and then my sugar level being 93 never any insulin under 100

when you take your glucose sugar level and you're under 100 you never take insulin

non filter air and it's always hot there is no cold air I asked for a fan for days now is not given

I'm not coughing I'm not sneezing I don't have diarrhea in fact it is a known fact that when you have tuberculosis you do not gain weight you lose weight

I have gained 32 pounds in the last month in fact had me enter room that was guarded by US Marshals because it was a federal quarantine required CDC

All x-rays been tested smears have been taken a cat scan has been done all to come with a conclusion that everything is negative now I am being in legally detained without it Federal court order

only a order from the CDC requiring because of tuberculosis I do not have to do not do not do not have to I need representatives from Congress the governor of South Dakota the governor of North Carolina to get involved

and your aunt Irving answer issue my release I am being held at corrective care which is a health facility that is for convicted in a I am NOT a convicted in May I am only being held on a detainer and under the US Constitution I should be not be held with convicted felons and confinement

this is locked down people that have already been convicted of crimes this is is a violation my rights

so I wish told by CDC all my rights would be here to I could order pizza I can

order take away I can use my phone where I choose to none of these right back size I can smoke cigarettes and I smoking area that would be provided for me

haha I bet I guess well I am here I said I did not want to be treated for diabetes that have given treatment to me after I said I do not want treatment for diabetes have given me medication that I refused but had to take that do not talk no how to ensure insulin day what offer me a year this of insulin and then my sugar level being 93 when you take your glucose sure level and your under a hundred your never take insulin

there should be considered mal practice I am Man a room with always not sweaty no fan as a and now for 5 days and is always hot there is no cold here I asked for a fan for days now is not Dr order so I can't have it

I'm not coughing I'm not seeing eye don't have diarrhea and skins have tuberculosis you do not gain weight use Lewis weight I have gained 32 pounds and the last month.

I have alerted the media also the Center for Disease Control made public information do not board list over Google and under the HIPAA Act against the law to issue and you not bored information because I had tuberculosis over the Internet so that everybody in the world can see that I have tuberculosis that is a HIPAA violations Act big violation and CDC has committed that crime

Over the last five days I have sent memos requesting my release reasons for my release emails to the assistant director of CDC Beth Bell Bell and the director mr. Thomas Frieden and no reply they have no dignity no pride no respect just a federal agency they can't answer my questions I have sent numerous request that I be released this CDC manual States regular tuberculosis and MDR tuberculosis must have three negative smears 2 chest x-rays that are negative in order to release somebody from quarantine they have gone far and beyond that now 8 Mares for chest x-rays and Cat Scan and all shows negative you can't make me be a guest in somebody's body that does not have TV I had to be 4 years ago and I was cured self cured it is very obvious that there is wrong doing by the Center for Disease Control and I need government officials to step in and to honor my request for my release otherwise the state of South Dakota is also responsible find me getting on a plane against my will as I said I do not want to fly I do not want to be on a plane and they made me fly it anyways and the u.s. marshals gave me a cigarette before I flew and when I get off the plane but that was not the stipulation the stipulation was that in South Dakota I would wear handcuffs on the plane as I wasn't an inmate and I wasn't under arrest and made to wear handcuffs state laws in South Dakota that is a human rights violation I demand for the state of South Dakota mr. Dennis Daugaard and the state of South Carolina Governor Nikki Haley and also for the mayor of Columbia

South Carolina Bob Horton to please challenge CDC and demand my immediate release otherwise South Carolina South Dakota and the federal CDC will be under a lawsuit 4 Falls detainer I am more than willing to wear a bracelet until the cultures come back but until right now I am negative and I want an immediate release on Monday and a response from the governor of South Dakota and a response from the governor of South Carolina and the mayor's office in Columbia South Carolina

Goldstein the first name of David I am currently being held in captivity that means against my will because of a mistake that the CDC is afraid to admit I have got reports from John Lincoln Hospital Chandler Regional Hospital Douglas County in Omaha and other people's opinions that I do not have or do not show any positive evidence to tuberculosis I am being held in a medical jail cell that is locked 24 hours a day with my rights being violated I'm not allowed to pick the food that I want to eat I get 2 tablespoons of rice a piece of bread and a piece of meat that's not enough for a meal I get nurses that come in send me a cup of warm juice hold their masks on their face slam the door and they're rude and obnoxious I get people making faces today because I am beat I have tuberculosis that I don't have I don't do not have 4 years ago I was healed and cured from tuberculosis all of the sudden the CDC gets a Anonymous phone call and somebody should I had tuberculosis and they lock me up and put me on a confinement order saying that I have tuberculosis and clear as day all medical testing all smears blood test and all chest x-rays are all showing negative tuberculosis I am still being held I am still trying to be forced to take medicine that I don't belong taking the doctor at the hospital dr. Shaffer is it going to see me unless I agree to take tuberculosis medication which is malpractice under the law you know take medicine that you're not sick for your take pills if your not sick I'm not a drug addict I don't take pills just to take them I am wishing and hoping does a cc and some media people hopefully the media people ask to see these questions why is he being held and I hope that they don't accept the answer because it might be he be hiding in Bones TV does not hide and bones if I

fresh hear that doctor has lied today on the 15th on the 14th and on the 13th Dr Schaefer saying that she was going through a lot me to go outside and get fresh air and she hasn't talked to Matt evidence giving that people are harassing me the lying to me and they're trying to destroy my life and trying to make me go mentally insane this is not fair this is not a my rights my civil rights or rights be on the constitution of America what they are doing here is wrong this is false imprisonment I have no choices I have no rights all of my rights are being taken away I'm locked down in a room 24 hours a day where I sweat when it's hot no pressure here no fresh air at all this is totally unfair and unconstitutional all of the evidence shows negative x-rays negative sputum negative all the way around I am being held against my will for medical purposes that do not exist do not exist do not exist do not exist do not exist are not present are not there I am a 47 year old white male I take care of myself and my good health Center for Disease Control is making a very large mistake they can't put their hands up in the air and they can't say that they have made a mistake mistake mistake mistake this is exactly what they've done and then. She needs to realize that even when those cultures come back they have no choice but to release me they can't keep me and definite they are trying to say that if I don't take the medicine that they're going to keep me and definitely and my cultures are negative they cannot keep me I'm letting all the media know what's going on and I would love to have an interview and would love the camera Crews to come up to the hospital and to interview me this is beyond a nightmare I have lost everything in my life and this is not fair this is not good is not good how they're treating me in here either this is not okay please investigate newspapers media I have coffee and CDC Executives including is the assistant director under Tom Frieden her name is Beth and also other legal persons with the CDC the citizens took a different stand they need to realize they made a mistake and they need to release me from where I'm at and allow me to go home

I want to apologize for earlier the spelling on my email wasn't very good and that is due to me not typing but using word predict text I was speaking and Google Voice typing and that's what I'm doing right now too here is the situation John Lincoln Hospital General Hospital and Chandler Arizona both Hospital there is record officially of me going into the hospital and asking to be tested 4 tuberculosis I feel the CDC is making a very big mistake and their decision making the hospital Avera McKennan Hospital has made very clear to CDC that I am not sick I have gained twenty eight pounds I have no night sweats no diarrhea and is no problem I'm not sick I would very much appreciate you letting me go I would very much appreciate if you want me to cooperate with CDC you let me go either on an ankle monitor or you let me go walk out and be done with this I'm willing to check in with CDC or any health department I'm willing to cooperate I would very much appreciate it just ends with in the next 24 hours I lost my sister I've just lost a best friend as well I am not sick the last other cultures from California where are negative my stairs and my chest x-ray at Avera Hospital are negative I would very much appreciate you allowing me to have my freedom I would very much appreciate in the meantime while you're waiting on the torturers for me to be released I will not run away and I will cooperate thank you very much. All news media my name is David Scott Goldstein social security number 030-64-5032 date of birth September 30th of 1968 the evidence here is very clear as day John Lincoln Hospital Chandler Regional Hospital Douglas County jail and Omaha have all tested me Force tuberculosis and the fact of the matter is that the CDC doesn't want to admit that they have made a mistake and I want all news media to step in as I copy you in to this email to the assistant director call CDC I asked that all media get involved I also have notification from another hospital that I am clear from TB and the last time that I was tested for tuberculosis was 3 months ago and I was negative the CDC is making a very big mistake and they are quarantined isolating me for something that I do not have is something that I am not positive the email address is above talk to the CDC and I asked for the CDC to let me go as is no proof that I'm positive to tuberculosis and I asked to be free and my rights to be restored as they've been taken away without any

just cause
