I said what do you mean - don't you see
I live here & the door was locked so I used
my key & entered with the United Necess
following the - a uniformed Cop who was standing
by the front door reading from a prepared
statement as I interrupted the excited Cops
said lots how henish. Ervin was standing by
me in front of the TV. When the uniformed
Cop got the part where he said you are not
not eating right & interpreted again I said
my finger against the Cops' belly & said
you are not eating right either - look
at your belly slicking out. Both of the Cops
left after my wife stated her feelings

Still undeterred Erin made arrangements with the Court Co. Cops or rather of my hairiest days to take my wife out of the house. I was at the Arivets Post 70 about 200 yards from our house & my wife called & said Erin was taking her shopping at Bells which is in the Crosscreek Shopping area. There was no Bells involved. Erin took my wife to the Helena House & left her there. While I was at the Arivets another member Millard "Moe" Morgan received a call on his cell phone. Moe told the caller "I'm looking at him now" which I believe was planned to keep me at the Arivets to gain more time. Any way I Co. Cops came in & wanted to take me aside to talk to me & said lets talk right here. They gave me some papers to read & I said I can't read this so they said just sign for it showing you got the papers. I did & they left. Any way when I went home there were many changes & took actions as per I thought were best. Erin took her mother to the Helena House in Fort Boyd. Went down a "hearing" of sorts in March of 2013. The judge & lawyer were called to another room & given Erin. I had

No opportunity to say one word. The judge
lawyers came out to the courtroom & the judge
declared my wife a protected person - Where is
justice there? Next at the Aug 2013 "hearing" my
so called attorney did little or nothing to represent
me or my version of events & again the judge called
all lawyers back to chambers & told them to work
out a settlement where there would be no irre-
parable family harm done & the judge signed
off on all pages of the order, again she should have
made the decision - not played a "Matchmaker"
which left a permanent rift with me after my
wife was continued in the Edena House the Court
appointed lawyer had my wife transported to
Columbia S.C. to be re-examined by Shrits out of
Blairgowrie Co & they said my wife should be a care
home - What a "blow" against the locals The
retirement was left to the greedy adult age kids
& not one dime was contributed toward food or
other household expenses. After a period of time
my wife was hospitalized with diverticulitis &
Eric came from Fla. I took my wife to Fla
& put her in a "home" there even after the
judges order terminating her as a temporary
guardian. After approx 11 months in Fla in

Captivity my wife was returned to Beaufort S.C.
but not home & the kids still controlled my
Wifes retirement income. Where is justice where?
now I can at least visit her every day which I do
but this situation needs to be corrected - which I
have asked for I been ignored - also since I
am without sufficient funds to hire another re-
liable lawyer our lives are running out as
we are both in our mid 80's in age. The
Criminal actions of the greedy kids have been
ongoing & the so called authorities are part
of the problem. This needs to be investigated and
exposed & proper legal action taken against all
of the "Wrongdoers" including the Coverup people
