Then the two younger adult age children wanted to take control of my wife's life & retirement income which was approx 4300.00 per month. At this wife Betty wanted to take my wife to Ohio & I flat said no. Later, Erin the other adult age kid was much more devious, cunning, & treacherous & in her actions made arrangements for an outside health care source to evaluate my wife. My wife was flawless in doing so & even outperformed the physical

I was told "you don't need me" Well Erin was

time we both trusted the "Kids". My wife

mother but I do not. Erin had the Per & Royal
Cops come to our house on a day when I was
going to the barber shop at Laurel Bay over.
It was on overcast day weatherwise & as I
started to enter a man in a blue & brown
suit said "I wouldn't go in there if I were you"
I said what do you mean - don't go in there
I live here & the door was locked so I used
my key & entered with the suited man
following me - a uniformed Cop was standing
by the front door reading from a prepared
statement so I interrupted & the suited Cops
said let him finish. Erin was standing by
main front of the TV. When the uniformed
Cop got to the part where he said you are ~~not~~
not eating right I interrupted again & stated
my finger against the Cops' belly & said
you are not eating right either - look
at your belly sticking out. Both of the Cops
left after my wife stated her feelings.

Still undeterred Erin made arrangements with the Court & Co. Caps on or rather of my haircut days to take my wife out of the house. I was at the Amvets Post 70 about 200 yards from our house & my wife called & said Erin was taking her shopping at Belks which is in the Cross Creek shopping area. There was no Belks involved. Erin took my wife to the Helena House & left her there. While I was at the Amvets another member Millard "Moe" Morgan received a call on his cell phone. Moe told the caller "I'm looking at him now" which I believe was planned to keep me at the Amvets to gain more time. Anyway 2 Co. Caps came in & wanted to take me asb to talk to me & I said lets talk right here. They gave me some paper to read & I said I can't read this so they said just sign for it showing you got the papers. I did & they left. Anyway when I went home there were many changes & I took actions as per I thought were best. Erin took her mother to the Helena House in Port Royal. Next came a "hearing" of sort in March of 2013. The judge & lawyers were called to another room & even Erin. I had

no opportunity to say one word. The judge
lawyers came out to the courtroom & the judge
declared my wife a protected person - where is
justice there? Mett at the Aug 2013 "hearing" - my
so called attorney did little or nothing to represent
me or my version of events & again the judge called
all lawyers back to chambers & told them to work
out a settlement where there would be no ir-
reparable family harm done & the judge signed
off on all pages of the order, again she should have
made the decision - not played a "Matchmaker"
which left a permanent "rift" with me after my
wife was continued in the Helena House - the Court
appointed lawyer had my wife transported to
Columbia S.C. to be re-examined by Shriniks out of
Beaufort Co & they said my wife should be a our
home - what a "blow" against the locals. The
retirement was left to the greedy adult age kids
& not one dime was contributed toward food or
other household expenses. After a period of time
my wife was hospitalized with diverticulitis &
Erin came from Fla. & took my wife to Fla
& put her in a "home" there even after the
judges order terminating her as a temporary
guardian. After approx 11 months in Fla in

Captivity my wife was returned to Beaufort S.C.
but not home. The Kids still controlled my
Wife's retirement income. Where is justice there?
Now I can at least visit her every day which I do
but this situation needs to be corrected - which I
have asked for & been ignored - also since I
am without sufficient funds to hire another un-
reliable lawyer our lives are running out as
we are both in our mid 80's in age. The
criminal actions of the greedy Kids have been
ongoing & the so called authorities are part
of the problem. This needs to be investigated and
opposed & proper legal action taken against all
of the "wrongdoers" including the coverup people
