Access to and copies of any and all correspondence since Jan. 1, 2010 between SCPRT and Sanctuary Pointe LLC, Robert Daffin, Elmon Henry and the US Corps of Engineers Savannah District regarding the leasing, subleasing and development of the approximately 200 acre tract on Lake Hartwell known as Sanctuary Pointe, located near the state Welcome Center on northbound Interstate 85 near Exit 1.
- 2) Requested by Tom Gardo, President, Denarius Group and followed up by Senator Tom Davis
Copies of all application submissions and grant approvals for the Hilton Head Island/Bluffton Chamber of Commerce.
- 3) Requested by David Tigges, attorney, McNair Law Firm (Hilton Head)
All correspondence (written, electronic or any means) and FOIA requests received or made within the last 90 days that request any information about or concern the Hilton Head Island/Bluffton Chamber of Commerce.
- 4) Requested by Peter Buonaiuto, MediaFeedia (social media marketing firm)
The conditions and prerequisites that must be met by an organization receiving funds under a DMO grant; the conditions and prerequisites for an organization to receive funds under a Co-op grant. Specifically provide information regarding what types of organizations can be eligible to receive funding under each grant type. What are the matching terms, if any (is each grant-type subject to a matching of dollars and if so what is the ratio of matching)? Of the two grants (SCPRT DMO in the amount of \$650,000 and SCPRT Co-op grant in the amount of \$550,000) how much was provided in matching funds and how much was provided that did not require matching funds?
