- 6:00 - 11:00 p.m. – Bike Night at 2473 Savannah Hwy, W. Ashley
- Vigil at the location of the shooting.

Update on Local Emergency Management Actions:

Jason Patno, Charleston County Emergency Management, called to let EMD know that North Charleston will be conducting an organizational meeting at noon today at the Coast Guard's Interagency Operations Center (formerly known as Seahawk). The meeting will focus on the plan to establish a command post for intel coordination purposes (including monitoring of social media) starting at 0700 tomorrow morning and running 24-hrs until 0700 Monday. The facility is better suited for sharing law enforcement sensitive information and is routinely used by the agencies.

North Charleston will lead the effort and staffing will comprise local and county officials. Some state/federal reps may also attend. SCEMD has not been requested to staff but we have personnel on standby.

EMD reports that key activities of interest are a wake scheduled for 1900 tonight and a funeral sometime tomorrow in Dorchester. EMD also indicates that there are small contingents of out-of-state groups in Charleston trying to establish organized activity but nothing that would be illegal or out of hand at this time.

No emergency management actions from the Governor or requested or advised at this time.

This afternoon, Charleston County Emergency Management requested information from EMD and the National Guard regarding contingency planning in case North Charleston requests assistance. This is normal protocol and for contingency planning purposes only. No official actions have been taken. At this time, EMD has no belief that state resources - beyond the aide of law enforcement (DPS, SLED) - will be needed.

General Livingston is aware of the inquiry and said that he will be out of town this weekend on drill but will be prepared if needed.

No actions from the Governor are requested or advised at this time.
