M I N U T E S

Mr. Rhodes called the meeting to order and explained that Mr. Poore was in the hospital. Councilman David Hooper gave the invocation.

On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to approve the minutes of the February 3, 1981 meeting as mailed.

Mr. David Watson presented a request from Solicitor George Ducworth to make an administrative change in his budget to accommodate the disbursement of State funds received through the office of Attorney General in the amount of \$41,121. On the motion of Mr. Bratcher, seconded by Mr. Hooper, Council voted unanimously to make the change.

Mr. Robert King presented Resolution #119 to approve an agreement with Oconee County to accept 27,500 evacuees in the event of an emergency at Duke Power Co's nuclear power plant near Seneca. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to adopt Resolution #119.

Mr. David Watson discussed purchasing three cars now being leased by the Assessor's Office. On the motion of Mr. Kinley, seconded by Mr. Bratcher, Council voted unanimously to approve the purchase for \$4020.00 each.

Mr. Watson presented bids for disaster warning equipment for Civil Defense. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to purchase from the low bid (Morris Communications) for the total amount of \$2,657.28.

Mr. Watson explained to Council that only one bid had been received for a radio dispatch console for EMS for \$12,218.12 from Morris Communications. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to purchase from Morris Communications.

Mr. Watson also discussed sealed bids for patrol cars. He explained that the County could save around \$6,000 by purchasing from the state. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to purchase from State.

The Clerk presented Ordinance #62 (Audit) for second reading. On the motion of Mr. Bratcher, seconded by Mr. Hooper, Council voted unanimously to adopt on second reading.

On the motion of Mr. Bratcher, seconded by Mr. Kinley, Council voted unanimously to adjourn at 7:16 p.m.
