Dear Rep. Wilson,

My husband and I applied for Medicaid in July 2007, and we have yet to hear back from them about our case. They initially denied our request because they said we hadn't turned in pay stubs. We did turn them in; when we got the rejection letter, I (Mary) called back, and it turned out they had them, but they didn't understand why they had been copied on one page....they were the ones that had copied them that way! And they didn't bother to call us and let us know they were confused--they just decided to lie and outright reject us for no clear reason.

Since then, which was several weeks ago, we still haven't heard from them. I called and left a message for the Medicaid worker, Arnetia Hayes, but I have heard nothing from her.

We also applied for TANF and food stamps back in August, and we still have not heard from them about the result. In the TANF case, I asked the caseworker, Torchia Henry, if she could look up my daughter's birth certificate, so we didn't have to pay the 12 dollars, and she said she didn't know how to do it. When I went to the Cooperative Ministry to see if they could help pay for it, they said they wouldn't b/c they knew the social services people should be able to verify it for free.

The whole point of these two programs, especially TANF, is that it is an emergency need. It is now October, our bills are mounting, and we have no medical coverage (my husband and daughter are both permanently disabled with Marfan syndrome), and we still have heard nothing good from the very department that is supposed to help us.

I will fax in that form to your office from your web-site, but I wanted to give you a heads up on what was going on.

Oh, and one of the main reasons why we are in a bad financial state is that we were going to buy a HUD house back in March. We were set to go to closing, and then we found out that day that HUD had never discovered there were tax liens on the house, so we ended up losing around \$4000 in that, b/c our realtor misled us, as did our mortgage company.

Dear Mrs. Hathaway:

Congressman Joe Wilson asked our agency to assist you in obtaining healthcare and financial aid benefits for your family.

The Department of Health and Human Services (DHHS) administers the Medicaid program. Your application for coverage under the Low Income Families (LIF) program was denied because we did not receive proof of your household income from each source listed on the application. However, we used the pay stubs we received to calculate your income, and I regret to inform you that your family income exceeds the allowable limit at this time.

You verbally requested an appeal on October 19, 2007 and we mailed you a *Request for a Fair Hearing Form 3260* to complete and return. Once this form is received, we will forward your request to the Division of Hearings and Appeals and you will be contacted shortly. If you have any questions about the appeal process, please contact Ms. Pat McWhite at (803) 741-1165, Ext. 132.

We are currently reviewing your LIF application to determine if your husband may be eligible under the Working Disabled program. Please contact Ms. Leighann Pfannenstiel at (803) 898-3093 if you have any questions about this process.

I have forwarded a copy of your correspondence to Mr. Allen Carter, Richland County Department of Social Services (DSS) Director, for his staff to review for possible financial assistance. DSS staff can address your questions regarding your Food Stamps and TANF applications.
