In SCWCC File Number 9209949, Mr. Bracey was awarded benefits of 20% to the back (\$20,784) with credit for temporary total payments made to him after May 4, 1994 (date of MMI). The carrier forwarded a check to Mr. Bracey at least two times, for \$12,297.71, the last one being January 25, 1999. This was the amount due minus attorney's fees and costs. It does not indicate in the file that this check was ever cashed.

By letter of October 8, 1999, I wrote to Mr. Bracey advising him of this same information. He was advised that it was his decision on whether or not to accept and cash the check forwarded to him by the carrier. I told him that the carrier had complied with the laws and regulations in the case. In this regard, there are letters in the file indicating Mr. Bracey had received the check for the award amount but failed to sign and return to the carrier a Form 19, Receipt of Compensation.

As to the allegation that the carrier would pay three additional days of temporary total benefits, there is nothing contained within the final orders to support this contention. With regards to the attorney fees, there is a Form 61, Attorney Fee Petition, in the file of SCWCC File Number 9202249, which was signed by Mr. Bracey and his then attorney, Ron Jebaily. It was amended and signed by former Commissioner Marchant on August 12, 1998. The amendment was for a reduction in costs from \$1,876.02 to \$1,558.29.

There are two files in which the Commission has adjudicated no claim. One is SCWCC File Number 9417689, an alleged hernia injury on May 15, 1994. Ron Jebaily, Mr. Bracey's former attorney, filed a Form 50 on April 2, 1996, but the claimant did not pursue it. In addition, SCWCC File Number 9257358 does not contain a Form 50, Notice of Claim/Request for Hearing, and the claimant did not pursue it either.

Governor Sanford, the South Carolina Workers' Compensation Commission and the judicial system has done as much for Mr. Bracey as the law will allow. His cases have been concluded with finality. I trust that this fully responds to your inquiry on behalf of Mr. Bracey. Should you have any questions or need additional information, please feel free to contact me.

I have a request:

Regarding my awarded workers compensation claim WCC #9202249. The enclosed letter is a copy from the Workers Compensation Commission answering Governor Sanfords' request on my behalf. The Commissions' letter contains incorrect data.

First paragraph: WCC#9209949 is incorrect, it should be WCC#9202249. Mrs. Clawson states: the carrier forwarded a check at least two times, for \$12,297.71, the last one being January 25, 1999. This is incorrect, (see enclosed) check dated 1/25/99, for \$20,784, to the best of my knowledge , they put a stop payment.

Mrs Clawson states: it does not indicate in the file that this check was ever cashed. I never received a check for \$12,297.71 or been notified in the past fifteen years.

It appears the files have a lot of incorrect data, so my request is, have the Commission send my award, regarding WCC#9202249, for \$12,297.71, and made out in my name with a Form 19 to sign, and request they send this award thru your office for your review to verify it is correct.
