A regular meeting of County Council of Charleston County was held on the 13<sup>th</sup> day of February, 2012, at 7:00 p.m., in the Beverly T. Craven Council Chambers, Second Floor of the Lonnie Hamilton, III Public Services Building, located at 4045 Bridge View Drive, Charleston, South Carolina.

Present at the meeting were the following members of Council: Teddie E. Pryor, Sr., Chairman, who presided; Colleen Condon; Henry E. Darby; Anna B. Johnson; Joseph K. Qualey; A. Victor Rawl; Herbert R. Sass, III; Dickie Schweers and J. Elliott Summey.

Also present were: W. Kurt Taylor, County Administrator and County Attorney Joseph Dawson.

Rev. Robert Reid gave the invocation. Council Administrator Kurt Taylor led in the pledge to the flag.

The Clerk reported that in compliance with the Freedom of Information Act, notice of meetings and agendas were furnished to all news media and persons requesting notification.

Ms. Johnson moved approval of Council's minutes of February 23<sup>rd</sup>, 2012, seconded by Ms. Condon and carried.

The Chairman said it was always a pleasure to have the opportunity to recognize one of the County's excellent, and requested Captain Todd McGeorge and his supervisor, Emergence Medical Director, Don Lundy to come forward.

The Chairman asked Mr. Lundy to explain why Council was honoring Captain McGeorge at this time.

Mr. Lundy stated that Captain McGeorge is a 17 year veteran with the Charleston County EMS and had worked his way up through the ranks to his current position as Training Officer for EMS. He further stated that Captain McGeorge is a graduate of the College of Charleston with a Bachelor Degree in Public Administration. He added that Captain McGeorge is a national reregistered paramedic and this year the first National Educators exam was held in SC by the National EMS Educators Council, the organization which certifies instructors in the United States and Captain McGeorge was only one of 5 instructors in the State to successfully pass this process, and he is now one of only 200 EMS instructors in the Nation certified at this level.

The Chairman expressed Council's pride in having such a superb and dedicated teacher in the EMS Department.
