Under the South Carolina Freedom of Information Act, §30-4-10 et seq., I am requesting copies of the purchase orders and quotes for all purchases of servers made by Department of Parks, Recreation, and Tourism for the time period of July 1, 2016-August 1, 2016.

If there are any fees for searching or copying these records, please inform me of the cost. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of South Carolina's IT purchases.

I would request a response in writing, within the 5 days described by law, if you intend to deny this request. Also, if you expect a significant delay in fulfilling this request, please contact me with information about when I might expect copies or the ability to inspect the requested record.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
