Does you local DMO take all tax monies to invest to promote the entire community to prosper and nothing else ? Does it produce apps , websites , local magazines that sells advertising that competes with for profit tax paying media ? Do they use these media products to profit and promote those who spend the most money ads , private chamber members , there own private members , board members ? Are they using tax monies to build these media products ? Do they

Exclude the entire business community on these media products , do they use these tax monies to buy google key words to bid up those keywords so high local media and other businesses can't afford them ? This drives traffic to the cvb DMO website and forces local businesses to buy ads and join or further profit the CVB DMO or chamber if comingled. Charleston CVB is perfect example of massive corruption and theft of public funds. A non profit / DMO and a separate chambers job is to help for profits prosper and profit not themselves or compete. A chamber , CVB DMO pays no corporate taxes, no IRS UBIT , pays no taxes for roads , schools , military , police . It's criminal what is happening and all really grew and got out of control when the Internet started from 1995 to 2010. These hybrid chambers CVB dmos are now nothing more than giant growing for profit media disguised as non profits to steal from us all including IRS and our tax system which hurts our country. We must get these chambers back to their original intent and think a properly run chamber is great for the community. The perfect model would be the small Greater Bluffton chamber and the Charleston chamber on the surface. Dmos must stop all this forporit activities and get back to thier job and soul purposes which is to simply promote and market the destination and all businesses in the community , not just a few. The ones that are part of this 5% like Hilton head , Myrtlebeach chambers must be audited and it will prove when they are prison will be the result . Same for the Charleston CVB this is the perfect example of massive corruption and theft of public funds and when this CVB is forencicly audited, prison will also be the result like happen in Palm beach fl.

A DMO tax money is for purpose of promoting the entire destination not just private chamber members..or those or spend the most money for ads on apps ,websites , local tourist magazines etc and to say a private chamber CVB DMO is one and the same just shows how out of touch with reality you are.
