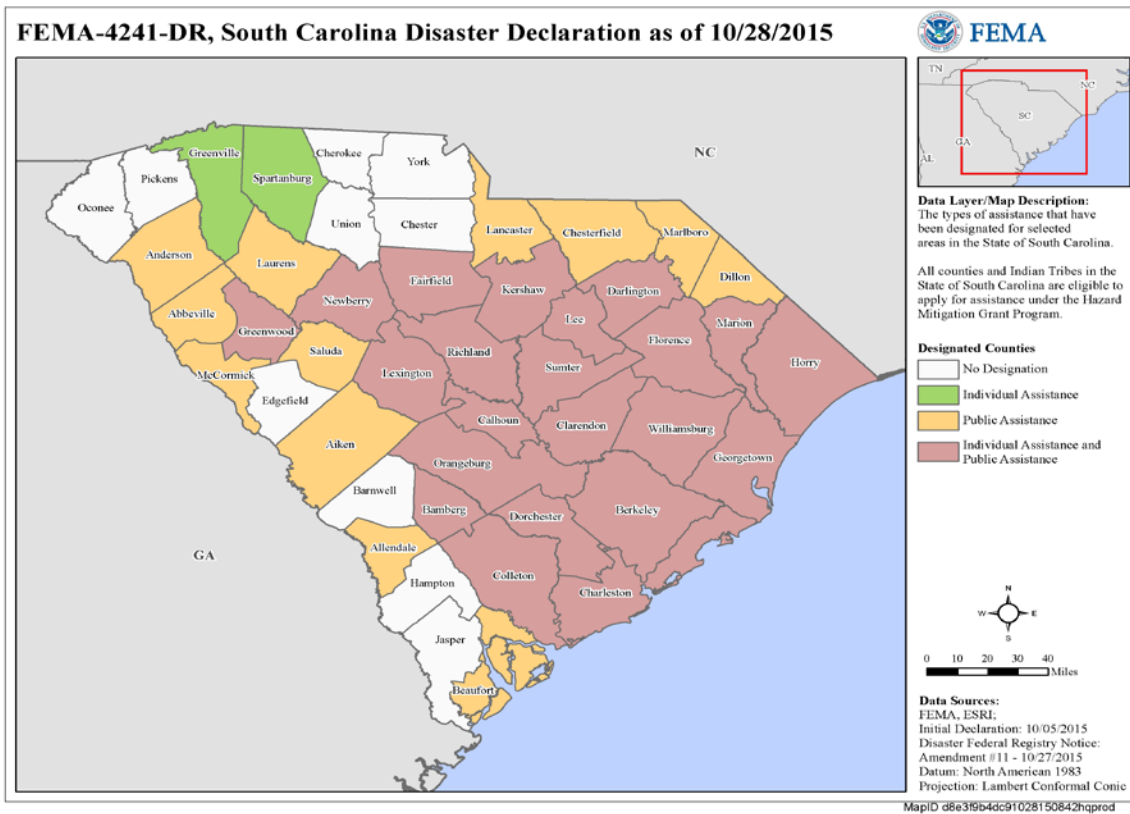

15. Threats or Disruptions to Infrastructure: South Carolina Department of Health and Environmental Control (DHEC) assessed 390 dams, issuing emergency orders to 63 of 390 assessed dams. Of those 63 dams, 28 (almost 45 percent) are in Richland County. In response to the emergency order, Department of Homeland Security (DHS) Office of Infrastructure Protection conducted an assessment of the Loblolly Timber Dam in Chester County, SC; participated with DHEC in identifying facilities that require inspections/assessments; and reviewed short-term recovery strategies received by private dam owners.
