

June 8, 1942.

The Budget Commission met in the office of the Governor at 11:00 o'clock A. M., all members being present.

General Charles P. Summerall, Col. J. P. Thomas, Col. L. S. Letellier and Mr. J. M. Moorer, representing The Citadel, appeared before the Commission and requested that the sum of \$6,800.00 be supplied by the Budget Commission to supplement an appropriation of \$50,000.00 made for the fiscal year 1942-43, to provide for an extension to the mess hall at The Citadel to accommodate an anticipated increase in enrollment there. The balance in the Civil Contingent Fund was insufficient to permit the Budget Commission to allocate this amount to The Citadel. The Commission agreed, however, to supply the needed amount, either by transfer from some other fund if possible to do so, and if not found possible to do this, the Commission agreed to authorize a transfer from The Citadel's 1942-43 Maintenance Account to the construction of an extension to the mess hall, and to support a deficiency appropriation for The Citadel next year to reimburse the Maintenance Account.

In view of this assurance from the Budget Commission, the Committee from The Citadel stated that they would proceed with the matter of contracting for the mess hall extension.

The following allocation was authorized by the Budget Commission from the Contingent Fund for National Defense:

The Governor's Office, Law Enforcement Division \$15,000.00 to provide additional constables which will be needed in connection with Army maneuvers to be conducted in this State.

The Commission declined to grant a request from South Carolinians, Inc., for the sum of \$2,000.00, to assist in the publication of the South Carolina Magazine, on the grounds that this request had been refused by the General Assembly.

The Commission declined to grant a request for the sum of \$1,000.00 from The South Caroliniana Library for the purchase of film and photostat paper to be used for duplicating certain records at Charleston and Columbia and possibly other points in South Carolina. The Secretary was instructed to advise the applicant that this matter should properly be taken up with the General Assembly at its next session.

The Commission then adjourned.
