A regular meeting of the Anderson County Council was held on December 3, 1991 at 4:30 p.m. in the Anderson County Chambers. Chairman Mike Holden presided.

Chairman Mike Holden called the meeting to order and Council Member David Hooper gave the invocation. Everyone stood and pledged allegiance to the flag.

Everyone joined in a moment of silence in memory of Marvin Mattison who passed away on Friday, November 29, 1991. Mr. Mattison was Community Service Director for Anderson County. Chairman Holden said that out of respect for the family of Mr. Mattison the meeting would be as short as possible to allow everyone to visit the family members at the church. All business matters would be deferred to the next meeting.

On the motion of Mr. Holden, seconded by Mr. Banister, Council voted unanimously to approve the November 12 and November 19, 1991 minutes as mailed.

Mr. Jack Crowe presented a resolution to Steven Stock who recently accepted new employment in Orlando, Florida. Mr. Stock is a member of the news media. Everyone wished Mr. Stock good luck with his new employment.

Mr. Mike Holden asked that \$10,000 be appropriated to Homeland Park Water & Sewer from his Special Project fund for sewer expansion for Saddleman Corp. Mr. Holden moved that this be done and Mr. Banister seconded. Vote was unanimous.

Mr. Holden moved to appropriate \$300.00 for Varennes Elementary School; "Just Say No" Club and Mr. Banister seconded. Vote was unanimous.

Mr. Holden said that the proposed ordinance dealing with firearms will be presented at the next meeting. The public hearing will be held at a 7:00 meeting; as requested by several citizens.

Mr. Bob Waldrep appointed Ms. Sharon Crout to the Planning & Development Board.


