Personhood legislation for debate, and so of course also the first time that it has

passed the full Judiciary Committee. When S.719 <http://www.scstatehouse.gov/sess121_2015-2016/bills/719.htm> passed a Judiciary Subcommittee

chaired by S.719 <http://www.scstatehouse.gov/sess121_2015-2016/bills/719.htm> primary sponsor, Senator Lee Bright <<http://www.scstatehouse.gov/member.php?code=0193181795>> (R-Greenville, Spartanburg)

on March 17

<<http://christiansforpersonhood.com/index.php/2016/03/17/sc-personhood-amendment-passes-senate-judiciary-subcommittee-favorably-by-2y-1n-vote-march-17-2016/>>, that was the first time Personhood legislation had been favorably passed

by a Senate Judiciary Subcommittee.

Now S.719 <http://www.scstatehouse.gov/sess121_2015-2016/bills/719.htm> will actually be placed on the [Calendar](http://www.scstatehouse.gov/sessphp/sencal.php) <<http://www.scstatehouse.gov/sessphp/sencal.php>> of the full South Carolina Senate.

However because **1)** the legislation is contested by some pro-"abortion" Senators,

and **2)** because there is a May 1st deadline under regular procedures for legislation

to crossover from one chamber to another, time is of the essence. S.719 <http://www.scstatehouse.gov/sess121_2015-2016/bills/719.htm> will need

to be voted by the SC Senate to be given "Special Order". It takes 2/3 of the Senators

present and voting for a bill to be given Special Order.

Senate Judiciary Committee meeting including the S.719 <http://www.scstatehouse.gov/sess121_2015-2016/bills/719.htm> debate and 11 - 5 vote on the SC Legislature website <<http://www.scstatehouse.gov/>>.

However, the immediate main points going forward are that:

1) May 1st is the deadline for passage of S.719 <http://www.scstatehouse.gov/sess121_2015-2016/bills/719.htm> by the SC Senate under regular procedures, and;

2) The next goal is to lobby all 45 SC Senators <<http://www.scstatehouse.gov/member.php?chamber=S>> (27 Republican, 18 Democrat, 1 vacancy)

for their commitment to support "Special Order" for S.719. We need a 2/3 vote of

those Senators present and voting for S.719 <http://www.scstatehouse.gov/sess121_2015-2016/bills/719.htm> to receive Special Order.
