M I N U T E S

PRESENT: Chairman - C. Edward Poore

Mr. Poore called the meeting to order and Councilman Robert L. Wiles gave the invocation.

On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to approve the May 6, 1980 minutes as mailed.

Mr. Grady Ireland and Mr. Marion Middleton with Fort Hill Cable TV, Inc. came before Council requesting an ordinance for consideration. Mr. Ireland stated that Fort Hill was interested in serving an area up to West Cherokee Road and Highway 8 and the surrounding areas of Williamston along with a two mile perimeter of Pendleton. Mr. Lusk asked that a map of the areas be submitted so that work could be started on the ordinance. Mr. John Rogers with West Pelzer TV stated that he was interested in School District 1-W. Pelzer, Pelzer and North or West Cherokee Road and Highway 8 up to Powdersville. Mr. Poore advised both to submit their maps and an Ordinance would be prepared for the next meeting.

Mrs. Rose Milam approached Council with a complaint against the Courthouse steps. She stated that the public law 90-480 reads that certain buildings or facilities be made assessable to handicapped persons. Mr. Lusk stated that certain steps are being taken to be in compliance with this Federal law. Mr. Poore received as information.

Mr. Poore advised Council that the Registration Board was out of money. The Board would need \$4,455 to finish this fiscal year. He stated that the Contingency Fund has only \$1,700 left. Mr. Poore recommended that the remaining funds in the Contingency Fund be transferred and search for additional funds within the budget that may become available. On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to transfer \$1,700 from the Contingency Fund (Account #910.79 to Account #160) to the Registration Board.

Mr. Robert P. Lusk presented second reading of Ordinance #52 (Emergency Medical Services). On the motion of Mr. Hooper, seconded Mr. Wiles, Council voted unanimously to approve on second reading.

Mr. Lusk presented second reading of Ordinance #53 (ANATS). On the motion of Mr. Gerrard seconded by Mr. Wright, Council voted unanimously to adopt on second reading.

Mr. Lusk read Ordinance #54 - West Pelzer Cable TV Franchise. On the motion of Mr.

Rhodes, seconded by Mr. Hooper, Council voted unanimously to pass Ordinance #54 on first reading.

Mr. Lusk presented an up-dated Affirmative Action Plan for Anderson County for 1980. On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted unanimously to pass the plan.

Mr. David Watson discussed federal regulations regarding the use of Revenue Sharing Funds. It is required to hold a public hearing for citizens to express their concern regarding the use of these funds. There were no comments.

On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to re-appoint Mrs. J.H. Ford, whose term has expired, to the Library Board.

Mr. Lusk stated that Council had received letters concerning the Wrecker Ordinance. Mr. Lusk said the South Carolina Highway Department had recommended that minimum wrecker safety standards be included in the ordinance. Council heard comments from Mr. Ronnie Cole and Glenn Thomason. On the motion of Mr. Wright, seconded by Mr. Rhodes, Council voted unanimously to receive as information.

Council discussed briefly a Blue Grass Festival scheduled to be held on the Edward Allgood Farm June 13 and 14. "No permit is required since the festival will not be held on Sunday"--This was the decision of Council.

On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adjourn at 7:50 p.m.
