Governor,

By statute, law enforcement entities must enter into contracts to assist one another across jurisdictional lines.

These contracts require city or county council approval. The S.C. Sheriff's Association has asked for an EO waiving these requirements during this declared disaster because they says it's too burdensome to get city and county council approval quickly. By statute, you have the authority to do this.

The Sheriff's Association said they are aware state officers are still available

to assist at this time, but they want the EO in case it becomes necessary. Chief Keel said he still has guys available and is unaware of any needs, but he also doesn't have a problem with it. We can either enter it now or wait until an actual need arises. Swati and Becca thought you should discuss on your 5:00 call.
