**Hurricane Matthew Recovery, USC Aiken, and Absentee Voting -- Update from Senator Tom Young -- September 7 to October 17, 2016**

Hurricane Matthew came and went and for the most part, those of us in Senate District 24 were spared the onslaught of the storm. However, other parts of our state and the Southeast were hit very hard with damage estimates in the U.S. expected to exceed \$10 Billion and nearly 900,000 in South Carolina without power. Meanwhile, flood waters continue to rise in some parts of our State. Please read below for more information and remember to pray for our State and its citizens during this time in need. If I can help you with an issue, please let me know. Thank you for allowing me to serve our District!

**Hurricane Matthew -- Disaster Recovery Information**

**S.C. Emergency Management Division** : To see the latest on the hurricane and other information related to the severe flooding and the state's recovery efforts, go [here](#). Specific county emergency management office contact information can be found [here](#).

**Federal Disaster Declarations:** To date, 13 counties have been issued a Major Disaster Declaration by the President, which means that local governments and certain nonprofits can seek reimbursements for costs associated with debris removal or emergency protective measures. Those counties are as follows: Beaufort, Berkeley, Charleston, Colleton, Darlington, Dillon, Dorchester, Florence, Georgetown, Horry, Jasper, Marion, and Williamsburg counties. Additional counties or categories of reimbursement may be added at a later date, depending on the results of Preliminary Damage Assessments as conducted by local, state, and federal representatives. Currently, assessments are ongoing in 25 counties total: Allendale, Bamberg, Barnwell, Beaufort, Berkeley, Calhoun, Charleston, Chesterfield, Clarendon, Colleton, Darlington, Dillon, Dorchester, Florence, Georgetown, Hampton, Horry, Jasper, Orangeburg, Lee, Marion, Marlboro,

Richland, Sumter, and Williamsburg Counties. As of late Friday, October 14, no South Carolina resident is eligible to apply for Individual Assistance from FEMA. For additional information, go [here](#).

**Road Closures:** To view a map of road and bridge closures in the state, go [here](#). Citizens are urged not to drive around barricades and should prepare for fallen trees, downed power lines and standing water in and around roadways. Some roadways that are not flooded today may be flooded in another day or later this week, depending on rising river levels, especially in the Pee Dee area.

**State Tax Deadlines :** The S.C. Department of Revenue is extending certain South Carolina tax deadlines for taxpayers in counties declared a federal disaster area. Aiken County is NOT one of those counties. To learn more, go [here](#).

**Farm Damage Assessment :** Officials from the South Carolina Department of Agriculture, Clemson University, South Carolina Farm Bureau, Farm Credit, and United States Department of Agriculture are working together to get an estimate of the scope of the damage. So far, the cotton and soybean crops appear to have been damaged as well as fall fruits and vegetables including peanuts. Meanwhile, power outages and other storm related issues have killed more than 200,000 birds and some chicken farmers are still using generators to power their coops. ### November 8 Elections

**Absentee Voting Ongoing:** For the November 8 elections, in person absentee voting is underway at the Aiken County Voter Registration and Elections Office in the County Administration Building from 9:00 am to 5:00 pm from Monday through Friday through November 7 and on Saturday, November 5 from 9 am to 1 pm. Other locations for absentee voting in the County and the applicable dates and times are as follows:

**Veterans Policy Advisory Committee:** In late September, Governor Haley, by Executive Order, created the Veterans Policy Advisory Committee to make recommendations for policy changes to the S.C. Military Base Task Force and to the Governor about state government can best serve veterans' needs. To see the Executive Order, go [here](#).

**State Retirement System :** Recently, the solvency of the state's retirement system has been back in the news. Earlier this year in April, the State Fiscal Accountability Authority heard testimony on the state's retirement system. After the meeting, the Governor and others stated that changes are needed to maintain the system's solvency. To see the meeting from last April, go [here](#). Last December, the Legislative Audit Council released its audit of the operations of South Carolina's state-administered pension funds. The Audit Council reviewed federal and state law, accounting and actuarial standards, investment returns, funded status, contributions, asset allocation, transparency, and conflicts of interest. The pension system is administered by the Public Employee Benefit Authority (PEBA), while the assets are invested by the Retirement System Investment Commission (RSIC). As of FY 13-14, the five state-administered pensions reported \$29.9 billion in assets and \$49.2 billion in liabilities. The system is comprised of approximately 70% local public employees and 30% state employees. Changes were made in 2012 and more changes are needed to keep the system properly funded. The audit report recommends decreasing the time the system pays off new pension debt and potentially capping alternative investments. To see the summary, go [here](#). In view of the audit report and the April presentation to the State Fiscal Accountability Authority, significant changes are likely forthcoming and necessary for the long term health of the system. Currently, there is a joint committee of Senators and Representatives holding hearings on the issue. To see their online postings, go [here](#). One of the potential ways to address the problem that will be back on the table like it was in 2012 is whether the state should prospectively switch to a defined contribution plan versus a defined benefit plan for new employees hired as of a certain date. Many companies in the private sector have done this in the past to address some of the same issues. In fact, I have heard from several constituents who worked for private companies when those companies switched their plans. There will be much more on this during the coming legislative session as the state cannot afford to avoid addressing the problem soon. I welcome your feedback.

The program loans up to \$36,000 in one time aid to homeowners who have fallen behind on mortgage payments for a variety of reasons. Acceptable causes include: unemployment, underemployment, a sharp reduction in self-employment income, a divorce, death of a spouse, unexpected medical bills from a catastrophic illness or injury, or damages stemming from the October 2015 floods. The home involved must be the applicant's primary residence and there is a cap on the size of the original mortgage loan amount.
