NOW, THEREFORE, be it resolved that the South Carolina State Highways and Public Transportation Commission does hereby commend Senator McConnell and Representative Aydlette for their foresight in recognizing a problem which has existed for many years and thanks them for introducing legislation to provide to the Department interest earned on State Highway Funds.
