WHEREAS, a majority of the members of the committee have made a determination that the Service Officer should be removed; and





EXECUTIVE ORDER

WHEREAS, it appears to my satisfaction that there exists in the City of Orangeburg wide-spread acts of violence and threats of violence, common disregard for the law and disorders of a general nature which constitute a danger to the persons and property of the citizens of the community, and threaten the peace and tranquility of the State, NOW, THEREFORE,

PURSUANT TO THE CONSTITUTION AND LAWS OF THE STATE OF SOUTH CAROLINA, I do hereby proclaim that a state of emergency exists in the City of Orangeburg; and in order to minimize the dangers to life, limb and property, I do hereby authorize, order and direct:

That any and all law enforcement officers of the State and its subdivisions, and the officials of the City of Orangeburg and all other persons in authority do whatever may be deemed necessary to maintain peace and good order;

I do further order that until subsequently determined by me that the need for such restriction is no longer necessary, that a curfew be and the same is hereby proclaimed in the City of Orangeburg to commence at 5 p. m. this date, February 9, 1968, and to expire at 6 a. m. of each following day and to commence and terminate at those times on subsequent days until hereinafter ordered. During the hours between 5 p. m. and 6 a. m. those persons within the city of Orangeburg shall remain within their homes and all businesses shall close during hours of curfew. Those persons required to attend to business of an emergency or essential nature shall continue as under normal conditions, but


shall obtain clearance from the Commanding Officer of the National Guard Troops or Chief J. P. Strom of South Carolina Law Enforcement Division or their designates. To avoid hardship and to insure that no persons will be unduly restricted, the said officials may in their discretion authorize such exceptions to the foregoing restrictions as they may feel advisable.

I do further order and direct that until further order by me that students in attendance at the South Carolina State College and Claflin College be and they are hereby required to remain upon their respective campuses except in accordance with such procedures as the officers above named may provide.

The Commanding Officer of the National Guard Troops and Chief J. P. Strom of South Carolina State Law Enforcement Division are hereby authorized to issue such directives as may be necessary to implement this order.





WHEREAS, it is desirable to have a single committee study and evaluate long and short range problems on Law Enforcement and Criminal Administration, and


WHEREAS, there exists no single committee to accomplish this purpose in South Carolina, and






WHEREAS administrative proceedings are now pending in the Probate Court for Hampton County in respect to the estate of Robert C. Rivers, deceased, and





Those persons required to attend to business of an emergency or essential nature shall continue as under normal conditions, but shall obtain clearance from the Commanding Officer of the National Guard Troops or Chief J. P. Strom of South Carolina Law Enforcement Division or their designates. To avoid hardship and insure that no persons will be unduly restricted, the said officials may in their discretion authorize such exceptions to the foregoing restrictions as they may feel advisable.


WHEREAS, during the past few years, significant growth in federal and state programs has created demands for data which have not been satisfied by the quantitative information produced heretofore, and


WHEREAS, the purpose of statistical research is to have a focal point in State government which will have knowledge of such needs so that consideration may be given to further improvement in the total data collection system, and



EXECUTIVE ORDER NO.

WHEREAS, Caleb McKeehen is a prisoner now confined in the Central Correctional Institution at Columbia, South Carolina, and

WHEREAS, the said Caleb McKeehen stands charged with the crime of larceny in Hamilton County, Tennessee, and

WHEREAS, the State of Tennessee desires the return of the said Caleb McKeehen to Hamilton County in order that he might be tried for the commission of the above stated crime, and

WHEREAS, the Honorable Buford Ellington, Governor of Tennessee, has requested that the said Caleb McKeehen be delivered into the custody of Frank Newell, Sheriff of Hamilton County, Tennessee, or his duly authorized deputy,

IT IS THEREFORE ORDERED that the Director of the South Carolina Department of Corrections be and is hereby authorized to deliver the said Caleb McKeehen into the custody of Sheriff Frank Newell or his duly authorized deputy to transport the said prisoner to Hamilton County, Tennessee, for the purpose of standing trial on the charge of larceny as above specified.

IT IS FURTHER ORDERED that at the conclusion of the trial Caleb McKeehen be returned to the State of South Carolina by Sheriff Frank Newell or his duly authorized deputy, to the prison from which he was received to serve the remainder of the prison sentence in South Carolina.

IT IS FURTHER ORDERED that any expenses incurred in carrying out this order should be borne by the officials of the State of Tennessee.




WHEREAS, it is desirable that the committee be broadened in scope to include problems in juvenile delinquency:
