Curtis, residing at 1500 Brentwood Way, Simpsonville, SC 29680, a candidate for Mayor of Simpsonville, SC an elective office as defined under Title 8, Chapter 13, Article 13, Sections 8-13-1300(4) and 8-13-1300(11) respectively the South Carolina Code of Laws.
- 2) On September 15, 2015 contribute the sum of \$500.00, a contribution as defined under Title 8, Chapter 13, Article 13, Section 8-13-1300(7) the South Carolina Code of Laws to the campaign of Matthew T. Gooch residing at 116 Howard Circle, Simpsonville, SC 29681, a candidate for Ward 1 Simpsonville City Council an elective office as defined under Title 8, Chapter 13, Article 13, Sections 8-13-1300(4) and 8-13-1300(11) respectively the South Carolina Code of Laws.
- 3) On September 2, 2015 and September 25, 2015 contribute on each occasion the sum of \$500.00 for an aggregate total of \$1000.00, a contribution as defined under Title 8, Chapter 13, Article 13, Section 8-13-1300(7) the South Carolina Code of Laws to the campaign of Jennifer B. Hulehan residing at 14 Sierra Court, Simpsonville, SC 29680, a candidate for Ward 3 Simpsonville City Council an elective office as defined under Title 8, Chapter 13, Article 13, Sections 8-13-1300(4) and 8-13-1300(11) respectively the South Carolina Code of Laws.
- 4) On September 17, 2015 contribute the sum of \$500.00, a contribution as defined under Title 8, Chapter 13, Article 13, Section 8-13-1300(7) the South Carolina Code of Laws to the campaign of Stewart K. Cummings (AKA Kenneth Cummings, AKA Ken Cummings) residing at 27 Open Range Lane, Simpsonville, SC 29681, a candidate for Ward 5 Simpsonville City Council, an elective office as defined under Title 8, Chapter 13, Article 13, Sections 8-13-1300(4) and 8-13-1300(11) respectively the South Carolina Code of Laws.

## ALLEGATIONS

Whereas Hendricks on or about the week of October 5, 2015 in coordination with Brebson Creative LLC, 104 NE Main Street, Simpsonville, SC 29681 whose registered owner is Elizabeth Kelley Fann residing at 604 Bramford Way, Simpsonville, SC 29680 and Xpress Press, 501B Richardson Street, Simpsonville, SC 29681 did cause the creation of an 8 ½ Inch by 11 Inch Brochure, a political communication and whereas the purpose was to design, mass produce and mail the subject Brochure to registered voters within the city limits of Simpsonville, SC to advocate the election of Mayoral Candidate Janice S. Curtis, Ward 1 Candidate Matthew T. Gooch, Ward 3 Candidate Jennifer B. Hulehan and Ward 5 Candidate Stewart K. Cummings (AKA Kenneth Cummings AKA Ken Cummings) therefore to ultimately influence the outcome of elective office as defined in Title 8, Chapter 13, Article 13, Section 8-13-1300(a)(b)(c) the South Carolina Code of Laws and whereas in the course of these actions did incur costs for graphic design, narrative, mass production and mailing using the standard bulk mail permit #558 registered to Xpress Press and whereas the benefit of said Brochure, a political communication inured in equal amounts to candidates Curtis, Gooch, Hulehan and Cummings therefore representing an in kind

contribution as defined in Title 8, Chapter 13, Article 13, Section 8-13-1300(20) and whereas the estimated number mailed was 5000 Brochures at an estimated total aggregate cost of \$2,822.01 and whereas the estimated in kind contribution to each candidate would total \$705.50.

- 1) Hendricks did on September 29, 2015 contribute the sum of \$1000.00 to the campaign of Janice S. Curtis, a candidate for Mayor of Simpsonville, SC and whereas Hendricks caused to be created, mass produced, mailed and received by residents on or about October 20, 2015 a Brochure, a political communication, representing a in kind contribution to the candidate of \$705.50 and whereas the resulting total aggregate contributions from Hendricks equaled \$1,705.50 in violation of campaign contribution limits as defined in Title 8, Chapter 13, Article 13, Section 8-13-1314(b) with a penalty as defined in Title 8, Chapter 13, Article 13, Section 8-13-1520(b).
- 2) Hendricks did on September 15, 2015 contribute the sum of \$500.00 to the campaign of Matthew T. Gooch, a candidate for Ward 1 Simpsonville City Council and whereas Hendricks caused to be created, mass produced, mailed and received by residents on or about October 20, 2015 a Brochure, a political communication, representing a in kind contribution to the candidate of \$705.50 and whereas the resulting total aggregate contributions from Hendricks equaled \$1,205.50 in violation of campaign contribution limits as defined in Title 8, Chapter 13, Article 13, Section 8-13-1314(b) with a penalty as defined in Title 8, Chapter 13, Article 13, Section 8-13-1520(b).
- 3) Hendricks did on September 2, 2015 and September 25, 2015 contribute on each occasion the sum of \$500.00 for an aggregate total of \$1000.00 to the campaign of Jennifer B. Hulehan, a candidate for Ward 3 Simpsonville City Council and whereas Hendricks caused to be created, mass produced, mailed and received by residents on or about October 20, 2015 a Brochure, a political communication, representing a in kind contribution to the candidate of \$705.50 and whereas the resulting total aggregate contributions from Hendricks equaled \$1,705.50 in violation of campaign contribution limits as defined in Title 8, Chapter 13, Article 13, Section 8-13-1314(b) with a penalty as defined in Title 8, Chapter 13, Article 13, Section 8-13-1520(b).
- 4) Hendricks did on September 17, 2015 contribute the sum of \$500.00 to the campaign of Matthew T. Gooch, a candidate for Ward 5 Simpsonville City Council and whereas Hendricks caused to be created, mass produced, mailed and received by residents on or about October 20, 2015 a Brochure, a political communication, representing a in kind contribution to the candidate of \$705.50 and whereas the resulting total aggregate contributions from Hendricks equaled \$1,205.50 in violation of campaign contribution limits as defined in Title 8, Chapter 13, Article 13, Section 8-13-1314(b) with a penalty as defined in Title 8, Chapter 13, Article 13, Section 8-13-1520(b).

An immediate task of the City Administrator should be to meet with the city's department heads for recommendations about the most important actions needed to make our city great once again.





