Bennett, the bill's sponsor, said Wednesday her bill would not stop physicians from performing the procedure.

**It would, however, require doctors to kill the fetus before it is removed, she said.**

**"All this bill does is require them to euthanize the baby before they rip it apart in the mother's womb,"**

**Bennett said.**

"I don't like that we even do this procedure," the Charleston Republican said. "But if we can at least make it more humane, less painful, to the unborn child ... I want to remove as much pain as I possibly can."

Months ago the South Carolina Republican Party passed a resolution supporting passage of the "South Carolina Unborn Child Protection from Dismemberment Abortion Act", (H-3548) which would make that specific type of abortion procedure illegal under state law.
