Bluff Road Bridges Open in January

Recovery Update

Three bridges on Bluff Road (SC 48) in Richland County were opened January 9.

In the Spring of 2016 the bridges were closed following an inspection that showed evidence of scour at each of the structures.

As a result of this inspection, emergency procurement for design and construction was used to expedite the project's

completion. The contract was awarded to Crowder Construction in June of 2016.

SCDOT continues to make progress on the

additional closures resulting from the October 2015 flood. The 24 remaining state road closures require full bridge replacement or are related to dam failures.

Hurricane Matthew Update

Several State Roads Open in January

Recovery Update

SCDOT continues to repair infrastructure damage and remove debris resulting from Hurricane Matthew.

Today, 17 state road closures remain in South Carolina, this is down 96% from the peak closure of 481 roads. The remaining closures are the result of major roadway/bridge damage or dam failures.

Many infrastructure repairs were performed in-house but SCDOT also

engaged contractors when necessary. Fourteen highway/bridge contractors are currently assisting with emergency repairs.

SCDOT also engaged six debris contractors to assist with storm related debris removal.

Over 1.9 million cubic yards of storm related debris has been removed using SCDOT's internal forces and debris contractors.

Vegetative debris removal should be completed in all

counties by late January. Non-vegetative debris will continue to be removed after this date in the areas where severe flooding occurred.
