Dear LGOA Staff:

When we were notified in July of one of the service providers serving more meals than were allowed, we began a new procedure of pulling the AIM report SC 63 monthly to cross-check the number of meals served with the number of clients receiving those meals for all meal service providers. The financial staff and I have a list of the number of serving days for each month in the current fiscal year that is referenced for this process. If the financial staff finds that a particular provider has gone over the amount of serving days in a month, then that is brought to my attention.

I contact the provider to request justification for the overage. If the justification does not meet special circumstances, then the units would not be allowed.

I have been notified that Senior Action and Senior Solutions had gone over this monthly limit. After contacting both providers, they both responded that there were activity issues with AIM and therefore meals had been added in other service months to be able to get payment for all the meals served. Several of the region's service providers had AIM activity issues with other services as well where they had to enter units in the next month in order to be reimbursed.
