Federal Personhood Bill **HR 586** (www.Congress.gov) is in the US House of Representatives, [House Judiciary Committee](#), Subcommittee on the Constitution and Civil Justice ([here](#)). These are the Subcommittee members ([here](#)). Why has this Republican-majority Subcommittee, with a Republican chairman, not held Subcommittee hearings on **HR 586** ???

If the Republican-majority US House and the Republican-majority US Senate truly wanted to **END** child-murder by "abortion", each chamber would pass Federal Personhood Bill **HR 586**, amended with the Article III, [Section 2](#), Clause 2 provision in the [US Constitution](#) referred to by Chuck Baldwin in the article above, to remove appellate jurisdiction from the US Supreme Court, as the US Constitution authorizes:

US Constitution
Article III
Section 2

Clause 2: In all Cases affecting Ambassadors, other public Ministers and Consuls, and those in which a State shall be Party, the supreme Court shall have original **Jurisdiction**. In all the other Cases before mentioned, the supreme Court shall have **appellateJurisdiction**, both as to Law and Fact, **with such Exceptions , and under such Regulations as the Congress shall make .**

Christians face Jail for refusing Gay Wedding Art

"Two Arizona calligraphy artists faced with fines and jail time for declining to take part in promoting gay 'weddings' are asking the state's Supreme Court to hear their challenge to the city of Phoenix's law that compels them create artwork that violates their religious beliefs," [reports](#) LifeSiteNews.

"Joanna Duka and Breanna Koski, owners of Brush & Nib Studio, face up to six months in jail, \$2,500 in fines, and three years of probation for each day that there is a violation of Phoenix City Code 18-4 (B).

"Not only are the Christian women threatened with jail time and fines should they refuse to create artwork celebrating gay 'marriage' because of the Phoenix law, they could also be prosecuted for publishing a statement on their website explaining that their religious convictions prohibits them from doing so.

"The women, represented by Alliance Defending Freedom (ADF), are asking the Arizona Supreme Court to take the case because 'the Phoenix ordinance illegally controls artistic expression,' according to ADF, 'violating the freedom of Duka and Koski to choose which messages they will convey and refrain from conveying.'

"Artists shouldn't be forced to create artwork contrary to their core convictions, and certainly not under threat of criminal fines and jail time," said ADF Senior Counsel Jonathan Scruggs.

"The government must allow artists to make their own decisions about which messages they will promote," Scruggs said.

"Breanna and Joanna are happy to design custom art for all people; they simply object to being forced to pour their heart, soul, imagination, and talent into creating messages that violate their conscience."

"Scruggs argued the case before the Arizona Court of Appeals (COA). The Court of Appeals had ruled in June that the Phoenix law would stand."

Church Evicted from Building after Resisting LGBTs

"An Indiana church has been evicted from its building after it posted an anti-LGBT sign," members have [reported](#) to Fox News.

"Remnant Fellowship Church in Auburn, Ind., put up a sign last month that read, 'LGBTQ is a hate crime against God,' WPTA-TV reported. But on Saturday, a church member told the news station that the congregation will need to find a new building to hold services.

"Church elder Robert Sturges previously defended the sign and said while the church does 'love' those who the sign targeted, it wanted 'to warn them that they are headed toward a cliff and if they keep going that way, they'll be destroyed.'

600 "We're trying to reach a certain group of people," Sturges told WANE-TV. "They're being told in our culture that homosexuality, transvestites, lesbianism and sexual immorality is ok. But the Bible clearly says that those

who practice these things will not inherit the Kingdom of God. In fact, it warns them that the wrath of God will abide upon them. And in the judgment, they will be lost and they will be sent to hell forever."

"We believe that. That's our faith," he said.

"Another unnamed church member told Raw Story that the congregation has been 'evicted' and that they are 'looking for another building.'"
