I have called your office today spoke with Doug and asked the questions below. Due to an incident that happened yesterday with Miss Tammy's little learning center.

Question:

Is it again DSS policy/reg for a daycare to remove child from a hot broke down bus.

Is it again DSS policy/reg for a daycare to let the windows on a hot bus down.

I was told both were against DSS policy. I find that hard to believe that in hot conditions when a daycare bus is broke down that neither of the above can happen.

If it is a policy then you need a policy change because that put those children in severe danger with it being so hot. Those children were on that hot bus for at least 20 to 25 minute.

If it were a parent leaving their child in a hot car, they would have been charged with neglect and arrested.
