Dear Mr./Ms. Gill:

According to our records, you owe the City of Greenville a debt in the amount of \$130.00 for the following: Court Fees/Fines (42128GX). You are hereby notified of the City of Greenville's intention to submit this debt on or about December 1, 2015 to the South Carolina Department of Revenue to be set off against your individual income tax return. Pursuant to the Setoff Debt Collection Act (Section 12-56-10), this amount plus all costs (which includes fees charged by the South Carolina Department of Revenue - \$25.00, the Municipal Association of South Carolina - \$25.00, the City of Greenville - \$25.00) will be deducted from your South Carolina individual income tax refund unless you file a written protest within thirty days of the date of this notice. If you file a joint return with your spouse, this amount will be deducted from the total joint return without regard to which spouse incurred the debt or actually withheld taxes.

The protest must contain all of the following information: (1) your name, (2) your address, (3) your social security number, (4) the type of debt in dispute, and (5) a detailed statement of all the reasons you disagree or dispute the debt. The original written protest must be mailed to Karen Osborne at the City of Greenville, PO Box 2207, Greenville, SC 29602.

You can avoid these collection costs and reduction of your individual income tax return by paying the debt's original amount (\$130.00) at 206 S. Main Street by November 9, 2015. If you have any questions or need more information, please call:
