Katherine:

After last night's victory celebration, Representative Lowe said he would be sending a video of the 250 – 300 citizens who approve of this new Special Tax District.

Please be aware that under the County Council plan about 45,000 of our citizens will get a tax decrease some as much as 18 mills when we treat all citizens equally in regards to paying for fire service. About 25,000 will see a tax increase, some of whom are the wealthiest of the citizens that live in Florence County.

To really get a perspective on this the Governor should realize, that all of this hurried up action without proper vetting by committees of the General Assembly to pass a bill that is legally flawed, and makes no provision for who funds them between now and when taxes are again mailed in November, or who is in charge of them until after September is all about those citizens having to pay \$37.60 more per 100,000 of valuation on their homes per year All citizens in this county who use fire and first response all over this county will pay the same rate of millage for that service under our consolidation of the districts. Paying for first response service is not just about where you sleep and you should not be able to pay less than everyone else, because where you sleep has a lot of high priced homes, these citizens receive the benefits of first response not just where they sleep, but where they work, where they play, where they drive. Why should other citizens have to pay more millage than them to provide this service for a few of the more affluent citizens in our county?

There are significantly more voters who will support this plan in Florence County than a select few in one small but well connected political area. This bill allows one fire district to be exempt from Act 388 but require all others to still be restrained in providing adequate fire service, when the people understand this, and they will before November, I am sure that their displeasure at this bad legislation will be reflected at the ballot box. The voters of Florence County overwhelmingly voted against the wishes of Senator Leatherman, Lowe and Crawford who tried their best all the way to the Supreme Court where they lost, and then lost again at the ballot box, to not allow home rule to operate as it should, to dictate from Columbia what is best on the local level and how to provide services for our citizens with the Capital Projects Sales Tax Penny #2 that measure passed with over 60% of the vote. This bill is fatally flawed legally in the opinion of many attorneys that I have talked with, I ask the Governor to please not sign a bill that in my opinion will not stand a legal challenge, please save the taxpayers of the County of Florence this expense. It cost our citizens hundreds of thousands of dollars to prevail against a powerful but disgruntled group of legislators last year, The

Governor could help us prevent this from happening again.
